Health Plan & Business Plan

UPON MOTION duly moved, seconded and unanimously carried the Alberta Health Services Board:

- a) approved the Alberta Health Services 2020-22 Health Plan & 2021-22 Business Plan in the form reviewed by the Finance Committee and the Board, with such nonsubstantive changes that management of Alberta Health Services considers necessary or advisable; and
- b) authorized and directed management of Alberta Health Services to deliver the 2020-22 Health Plan & 2021-22 Business Plan to the Minister of Health for approval, and after receiving such approval, make such Health Plan & Business Plan available to the public through the AHS website.

Delegation of Authority: Good Samaritan Society

UPON MOTION duly moved, seconded and unanimously carried the Alberta Health Services Board:

- a) approved the following amendments to The Good Samaritan Society (A Lutheran Social Service Organization) Operating Service Agreement:
 - i) to add a supportive living service schedule for one hundred and twenty-one spaces for the Park Meadows Village facility in Lethbridge for a five year term, on the terms and conditions reviewed by the Committee, with such nonsubstantive changes that management of Alberta Health Services considers necessary or advisable; and
 - ii) to extend for one year, to September 20, 2022, three Comprehensive Home Options of Integrated Care for the Elderly programs, on the terms and conditions

reviewed by the Committee, with such non-substantive changes that management of Alberta Health Services considers necessary or advisable; and

b) delegated the authority to the Alberta Health Services President and CEO to execute the agreement to effect such amendments referred to above on behalf of the Alberta Health Services Board in accordance with the *Delegation of Authority and Establishment of Controls for Commitments* Policy.

AHS 2020-21 Annual Report

UPON MOTION duly moved, seconded and unanimously carried the Alberta Health Services Board:

- a) approved the Alberta Health Services 2020-21 Annual Report in the form reviewed by the Audit & Risk Committee and the Board, with such non-substantive changes that management of Alberta Health Services considers necessary or advisable; and
- b) authorized and directed management of Alberta Health Services to deliver the Annual Report to the Minister of Health, and to later make the Annual Report available to the public through the Alberta Health Services website.

Amended Midwifery Staff Bylaws
