

Frequently Asked Questions

What is the project trying to achieve?

The Alberta Children's Hospital (ACH) is in the process of developing an ACH Master Site Plan for site and service evolution and growth through 2030. The Master Site Plan will develop a clear understanding of the current infrastructure and bed capacity, and needs going forward. Through the consultation process, ideas and input will be considered to help develop a flexible, scalable plan that addresses service demands and available resources between now and 2030.

Who are you asking to get involved?

This project seeks the perspectives of current and potential service users, including children and youth, and their families, as well as ACH care providers and service partners (other child health care providers, research and education partners, community based service providers etc.) who are stakeholders in the site and services of the ACH. We want to engage as many people as possible, and there will be multiple opportunities to participate.

Why this consultation process?

The Alberta Children's Hospital incorporates patient and family-centered care in all that we do, including involving patients and families in planning for the future of our hospital, listening to one another, sharing ideas and information and asking and answering questions to inform decision-making. The consultation process allows us to hear from current and potential service users, as well as those providing the services and our service partners.

When will all of this happen?

Participation in the consultation process will run from September 20, 2016 through October 30, 2016.





What will you do with input and feedback?

Your ideas will be complied and provided to the ACH Master Planning Committee for their consideration in developing priorities, strategies and actions in the 2030 Master Plan. You can expect a summary report of what we heard in late 2016.

We are eager to hear from a variety of stakeholders with diverse experience, perspectives and knowledge, including patients and their families who access the ACH services frequently, those who access services only occasionally, or are potential users.
