Hand Hygiene Scenario

Are you an expert Hand Hygiene Reviewer? Keep your knowledge topped up with this commonly mistaken scenario!

Scenario December 2023: A nurse is working on a WOW (Workplace on Wheels) in the hallway. They then perform hand hygiene, don a pair of gloves, and wipe down the surfaces of the WOW. They then doff their gloves, perform hand hygiene and takes the WOW into a patient's room. The nurse moves from the WOW to the patient, and then returns to the WOW. They then again, move to contacting the patient and then back to the WOW once more. Finally, the staff member drags the WOW out of the patient's room, performs hand hygiene, dons a pair of gloves, and wipe down the surfaces of the WOW. They then proceed to the nursing desk in the healthcare environment.

Hand Hygiene Reviews & Connect Care Devices

How do we record hand hygiene reviews when staff are using connect care devices?

When doing hand hygiene reviews, connect care devices could be considered:

- ➤ Healthcare environment, if not cleaned between patients.
- Patient environment, if cleaned immediately before and after use with a patient.



Although there are hand hygiene expectations required in cleaning of equipment, those fall outside the scope of the hand hygiene review process and cannot be recorded as observations; however, if you observe a staff donning gloves to clean equipment, then a Moment 2 would be recorded as gloves are considered a clean supply.
