DEFINE OPPORTUNITY

- ✓ The Emergency Department (ED) is the ideal location to prevent potential medication errors from occurring.
- ✓ This pilot project was designed to improve safety and medication management for patients in the ED.



ACT TO IMPROVE

- ✓ Two 1.0 full-time equivalent (FTE) clinical pharmacist positions were funded for a one year pilot at PLC and RGH
- ✓ ED pharmacists worked Monday to Friday day shifts using their full scope of practice to provide direct patient care

Table 1. Core Responsibilities of ED Pharmacists

Provide proactive, collaborative medication management.

Assist with Medication Reconciliation/Best Possible Medication History completion for complex/high risk patients.

Assistance and management of specialized clinical services including: anticoagulation management, pain management and antimicrobial stewardship.

Drug information requests.

Participation in seamless care activities.

Troubleshoot medication related problems.

Document all interventions and clinical activities in the patient's permanent health record.

Document clinical workload on a daily basis in WorkTrax®.

Practice within their full scope including incorporating Additional Prescribing Authority and ordering of labs.

RESULTS


During the first six months in the ED, pharmacists recorded being involved in the care of over 3,100 patients.

Indirect Medication Management	144	18.5

85% of survey respondents agreed or strongly agreed that pharmacists were a valuable member of the ED team and improved patient care.

Figure 2. Utilization of Targeted Clinical Services





Figure 3. Thematic Analysis of Anecdotal Observations



SUSTAINABILITY

- ✓ Following the pilot project, permanent funding was provided for continuation of the clinical pharmacist role as part of the ED multidisciplinary team at both sites.
- ✓ Future opportunities exist to evaluate the role of Clinical Support Pharmacy Technicians (CST) in the ED.
- ✓ Extending pharmacy support hours to accommodate evenings and weekends coverage of the ED was a common request from staff.
