The following checklist will assist you in keeping your facility pest free and in compliance with applicable legislation. A record of all pest control measures, whether carried out by the food establishment operator or a certified pesticide applicator should be completed monthly and kept in a file or binder. All records should be maintained onsite for 12 months to be reviewed by your Public Health Inspector.
