

## ORDER OF AN EXECUTIVE OFFICER

**To:** Tony Tam

Edna Tam "the Owner"

**RE:** Those housing premises located in Calgary, Alberta and municipally described as:

4615 Maryvale Road NE

WHEREAS I, an Executive Officer of Alberta Health Services, have inspected the above noted premises pursuant to the provisions of the Public Health Act, RSA 2000, c. P-37, as amended;

**AND WHEREAS** such inspection disclosed that the following conditions exist in and about the above noted premises which are or may become injurious or dangerous to the public health or which might hinder in any manner the prevention or suppression of disease, namely:

- a. There was major build up of garbage and clutter in the property to the point where the occupant's ability to access parts of the suite other than the bathroom and occupant's bedroom, including the kitchen, west bedroom, basement, furnace and entry/exit door, is severely obstructed and/or impossible.
- b. Cat litter box in the basement was full of feces.
- c. There was no smoke alarm near the bedrooms.
- d. There was garbage and junk stored on top of the kitchen stove. The kitchen stove knobs were also missing.

**AND WHEREAS** such inspection disclosed that the following breaches of the Public Health Act and the Housing Regulation, Alberta Regulation 173/99, and the Minimum Housing and Health Standards exist in and about the above noted premises, namely:

- a. There was major build up of garbage and clutter in the property to the point where the occupant's ability to access parts of the suite other than the bathroom and occupant's bedroom, including the kitchen, west bedroom, basement, furnace and entry/exit door, is severely obstructed and/or impossible. This is in contravention of section 5(2) of the Housing Regulation AR173/1999 which states that: No person shall cause or permit any condition in housing premises that is or may become injurious or dangerous to the public health, including any condition that may hinder in any way the prevention or suppression of disease.
- b. Cat litter box in the basement was full of feces. This is in contravention of section 5(2) of the Housing Regulation AR173/1999 which states that: No person shall cause or permit any condition in housing premises that is or may become injurious or dangerous to the public health, including any condition that may hinder in any way the prevention or suppression of disease.
- c. There was no smoke alarm near the bedrooms. This is in contravention of section IV(12) of the Minimum Housing and Health Standards which states that: Smoke alarms within dwellings shall be installed between each sleeping area and the remainder of the suite and, where hallways serve the sleeping areas; the smoke alarms shall be installed within the hallway.

d. There was garbage and junk stored on top of the kitchen stove. The kitchen stove knobs were also missing. This is in contravention of section IV(14)(a)(iv) of the Minimum Housing and Health Standards which states that: Every housing premises shall be provided with a food preparation area, which includes: a stove and a refrigerator that are maintained in a safe and proper operating condition. The refrigerator shall be capable of maintaining a temperature of 4 degrees C.

## NOW THEREFORE, I hereby **ORDER** and **DIRECT**:

- 1. That the Owner immediately undertake and diligently pursue the completion of the following work in and about the above noted premises, namely:
  - a. Remove all garbage and debris in the property and ensure emergency exits are not obstructed.
  - b. Remove all garbage and debris around the furnace and ensure area around the furnace is clear.
  - c. Install a fully functional smoke alarm near the bedrooms.
  - d. Remove all garbage and junk from the kitchen stove.
  - e. Repair or replace the kitchen stove so it is in good working condition.
- 2. The work referred to in paragraph 1 shall be completed by December 31, 2023.

The above conditions were noted at the time of inspection and may not necessarily reflect all deficiencies. You are advised that further work may be required to ensure full compliance with the Public Health Act and regulations, or to prevent a public health nuisance.
