

ORDER OF AN EXECUTIVE OFFICER CLOSED FOR TENANT ACCOMMODATION PURPOSES

RE: Those housing premises located in Red Deer, Alberta and municipally described as:

Red Deer Resort & Casino - Room 602, 3310 50 Avenue

WHEREAS I, an Executive Officer of Alberta Health Services, have inspected the above noted premises pursuant to the provisions of the Public Health Act, RSA 2000, c. P-37, as amended;

AND WHEREAS such inspection disclosed that the following conditions exist in and about the above noted premises which are or may become injurious or dangerous to the public health or which might hinder in any manner the prevention or suppression of disease, namely:

a. Based on the information received from the Royal Canadian Mounted Police (RCMP), the premises (Room 602) was used for the consumption of fentanyl. RCMP confirmed with the occupying tenant that fentanyl was consumed inside the premises and observed evidence supporting its use.

AND WHEREAS such inspection disclosed that the following breaches of the Public Health Act and the Housing Regulation, Alberta Regulation 173/99, and the Minimum Housing and Health Standards exist in and about the above noted premises, namely:

a. Based on the information received from the Royal Canadian Mounted Police (RCMP), the premises (Room 602) was used for the consumption of fentanyl. RCMP confirmed with the occupying tenant that fentanyl was consumed inside the premises and observed evidence supporting its use. This is in contravention of section 5(2) of the Housing Regulation which states that "No person shall cause or permit any condition in housing premises that is or may become injurious or dangerous to the public health, including any condition that may hinder in any way the prevention or suppression of disease."

AND WHEREAS, by virtue of the foregoing, the above noted premises are hereby declared to be **Closed for Tenant Accommodation Purposes**.

NOW THEREFORE, I hereby **ORDER** and **DIRECT**:

- 1. That the owner immediately secures the above noted premises from unauthorized entry.
- 2. That the Owner immediately undertake and diligently pursue the completion of the following work in and about the above noted premises, namely:
 - a. Hire the services of a professional remediation company that specializes in hazardous materials remediation to clean the unit of fentanyl contamination. Cleaning of the unit must be completed in such a manner that protects the general public and future occupants from fentanyl contamination during and after the cleanup.
 - b. Submit a remediation plan to an Executive Officer of Alberta Health Services for approval and acceptance prior to undertaking any clean-up of the unit.
 - c. Provide documentation of all work completed to an Executive Officer of Alberta Health Services.
- 3. That until such time as the work referred to above is completed to the satisfaction of an Executive Officer of Alberta Health Services; the above noted premises shall remain closed for tenant accommodation purposes.

The above conditions were noted at the time of inspection and may not necessarily reflect all deficiencies. You are advised that further work may be required to ensure full compliance with the Public Health Act and regulations, or to prevent a public health nuisance.
