


LEADERSHIP QUOTE

KEY ACHIEVEMENTS

The Seniors and Continuing Care Provincial Advisory Council (SCCPAC) is comprised of volunteer members who share their lived continuing care system experience with Alberta Health Services (AHS) to help improve the quality, accessibility and availability of continuing care services in Alberta. Members strive to capture lived experience and ensure patients and families are at the centre of all healthcare activities, decisions and teams. Working in partnership with AHS, Council considers existing and emerging topics related to continuing care and provides recommendations to the AHS Board and program and senior leadership for consideration. Our key achievement for the year include:

- Council participated on the Request for Expressions of Interest and Qualifiers for Home Care Services in Alberta, influencing parameters of new contracts for future use with operators who are considered pre-qualified for home care service delivery in the province.
- Members received information and provided feedback on Continuing Care Transformation including key areas, Shift to Care in the Community, Enhance Workforce Capacity, Increase Choice and Innovation, and Improve Quality.
- Council received information about AHS Connect Care and Continuing Care and discussed challenges for primary care providers and others requiring third-party access. Council provided feedback on opportunities Connect Care will create for continuing care clients across the province.
- 2023 saw term expiry of nine founding Council members. A warm farewell and great thanks for dedicated work wished to Diahann Polege-Aulotte, Irene Pirie, Jim Hubbard, Joan Monson, John Erkelens, Julie Kelndorfer, Linda Grant, Ray Clark and Susan Sommerfeldt.
