Declaration of Conflicts of Interest

1. [AHSB17-03] 2017/18 Authorization to Spend

The 2017/18 budget has yet to be approved by Alberta Health. Accordingly, the Finance Committee and the AHS Board has reviewed a request for an authorization to spend for the period from April 1, 2017 to August 31, 2017.

The Finance Committee recommended that the Board approve an authorization to spend until the final budget is approved. In addition to AHS's own source revenues, AHS has received assurances from Alberta Health regarding the first ten semi-monthly base operating grant payments.

UPON MOTION duly moved, seconded and unanimously carried the Alberta Health Services Board authorized AHS to incur:

- 1. maximum expenses of \$6.2 billion for the period April 1, 2017 to August 31, 2017; and
- 2. maximum capital expenditures of \$230 million for the period April 1, 2017 to August 31, 2017.
