Board Committee Structure

UPON MOTION duly moved, seconded and unanimously carried the Alberta Health Services Board approved:

- a) the disestablishment of the existing Finance Committee, Audit & Risk Committee and Governance Committee;
- b) the establishment of the Finance & Audit Committee and the Governance & Risk Committee as governance committees of the Alberta Health Services Board and the approval of the Terms of Reference for both Committees, as reviewed by the Governance Committee and the Alberta Health Services Board, with such nonsubstantive changes as management of Alberta Health Services considers necessary or advisable;
- c) the amendments to the Board Terms of Reference, as reviewed by the Governance Committee and the Alberta Health Services Board, with such non-substantive changes as management of Alberta Health Services considers necessary or advisable; and
- d) directed that the Terms of Reference be posted on the Alberta Health Services public website.

Mandate and Roles Document

UPON MOTION duly moved, seconded and unanimously carried the Alberta Health Services Board approved the Mandate and Roles Document, as reviewed by the Governance Committee and the Alberta Health Services Board, with such non-substantive changes as management of Alberta Health Services considers necessary or advisable. The Alberta Health Services Board Chair will submit the Mandate and Roles Document to the Minister of Health.

AHS Infection Prevention and Control 2021/22 Annual Report to Alberta Health

UPON MOTION duly moved, seconded and unanimously carried the Alberta Health Services Board approved the Alberta Health Services Infection Prevention and Control 2021/22 Annual Report to Alberta Health, as reviewed by the Quality & Safety Committee, with such non-substantive changes as management of Alberta Health Services considers necessary or advisable. Upon approval, the Alberta Health Services Board Chair will submit the Annual Report to Alberta Health.

Interim Authorization to Spend for COVID-19 and Surgery Recovery Costs in 2022/23

UPON MOTION duly moved, seconded and unanimously carried the Alberta Health Services Board approved amendments to the authorization to spend related to costs for COVID-19 and surgery recovery previously approved by the Alberta Health Services Board on June 1, 2022, as follows:

- a) the interim authorization period under the COVID and Surgery Recovery Authorization to Spend be extended to end on December 31, 2022 rather than September 30, 2022;
- b) the maximum expenses under the COVID and Surgery Recovery Authorization to Spend be increased from \$640 million to \$856 million for the extended period April 1, 2022 to December 31, 2022; and
- c) the maximum capital expenditures under the COVID and Surgery Recovery Authorization to Spend will be increased from \$27 million to \$30 million for the extended period April 1, 2022 to December 31, 2022.

<u>Delegation of Authority – Amendment of Yarrow Limited Partnership Amended and Restated</u> Master Services Agreement

UPON MOTION duly moved, seconded and unanimously carried the Alberta Health Services Board:

- a) approved the amendment to the Yarrow Limited Partnership Amended and Restated Master Services Agreement to add 72 continuing care supportive living services at Aspen House Care Residence, with such non-substantive changes to the existing terms of the agreement as management of Alberta Health Services considers necessary or advisable;
- b) delegated the authority to the Alberta Health Services Interim President & CEO to execute the agreement that gives effect to such amendments referred to above on behalf of Alberta Health Services, in accordance with the *Delegation of Authority and Establishment of Controls for Commitments* Policy.
