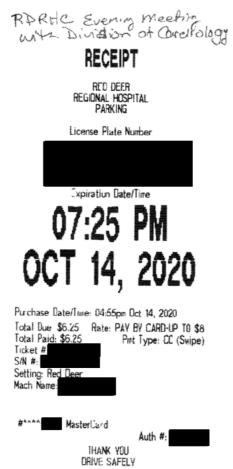
4) Other
