1. [OA13-10] Infection Prevention and Control 2012/13 Annual Report to Alberta Health

The 2012/13 Infection Prevention and Control ("**IPC**") Annual Report was approved for submission to Alberta Health, as required in the Alberta Health (2011) IPC Standards for Accountability and Reporting. The report provides an overview of the province-wide IPC program established within AHS and actions taken towards reducing the risk of health care associated infections. RESOLUTION OF THE OFFICIAL ADMINISTRATOR OF ALBERTA HEALTH SERVICES

WHEREAS this Resolution is enacted pursuant to Section 11(2)(a) of the *Regional Health Authorities Act* (Alberta) and the Order of the Minister of Health of Alberta (the "Minister") dated September 10, 2013, appointing Dr. John Cowell as the Official Administrator of AHS (the "Official Administrator");

AND WHEREAS pursuant to Section 3 of the 2011 Alberta Health Standards for Infection Prevention and Control – Accountability and Reporting, an Annual Report on Infection Prevention and Control activities, programs, monitoring and compliance in AHS must be provided to Alberta Health by September 30th of the following fiscal year;

NOW THEREFORE BE IT RESOLVED THAT:

- 1. The AHS Infection Prevention and Control 2012/13 Annual Report to Alberta Health (the "IPC Annual Report") is hereby approved on substantially the terms and conditions reviewed by the Official Administrator.
- 2. The Official Administrator will hereby deliver the IPC Annual Report to the Minister.

2. [OA13-11] Supportive Living Contracts

There are several supportive living agreements between AHS and service providers for new continuing care capacity that require approval by the Official Administrator because such agreements exceed the President and CEO's signing limits. Delegation of signing authority to the President and CEO with respect to these agreements enables AHS to execute these contracts with service providers in a timely manner

RESOLUTION OF THE OFFICIAL ADMINISTRATOR OF ALBERTA HEALTH SERVICES

WHEREAS this Resolution is enacted pursuant to Section 11(2)(a) of the *Regional Health Authorities Act* (Alberta) (the "RHA") and the Order of the Minister of Health of Alberta (the "Minister") dated September 10, 2013, appointing Dr. John Cowell as the Official Administrator of AHS (the "Official Administrator");

AND WHEREAS pursuant to Section 6(2) of the RHA, the regional health authority may delegate any power or duty conferred or imposed on it under the RHA or any other provincial legislation, to a committee of the regional health authority, to any of its employees, officers or agents or to a community health council;

AND WHEREAS the AHS Delegation of Authority and Establishment of Controls for Commitments Policy (the "Policy"), delegates and establishes appropriate limits on commitments to be approved and executed by the President and Chief Executive Officer of AHS (the "CEO") on behalf of AHS;

AND WHEREAS the below Supportive Living Contracts exceed the CEO's Approved Limits (as defined in the Policy);

NOW THEREFORE BE IT RESOLVED THAT:

Supportive Living Contracts

- 1. The CEO is hereby authorized to approve and execute the following Supportive Living Contracts on behalf of AHS, and any amendments thereof, each on substantially the terms and conditions reviewed by the Official Administrator:
 - (a) the agreement with targeted start date of March 1, 2015, between AHS and Age Care Health Services Inc. for the funding of the operation of 125 Supportive Living spaces at the Seton facility, for a 30 year term and in the maximum term amount of \$165,500,000;
 - (b) the agreement with targeted start date of December 1, 2014, between AHS and Age Care Health Services Inc. for the funding of the operation of 125 Supportive Living spaces at the Walden Heights Seniors Community facility for a 30 year term and in the maximum term amount of \$150,300,000;
 - (c) the agreement with targeted start date of June 1, 2014, between AHS and The Bethany Care Society for the funding of the operation of 100 Supportive Living and Long Term Care spaces at the Didsbury facility in the maximum term amount of \$117,244,770 (assuming a 30 year term) or equivalent given the term negotiated upon;

- (d) the agreement with targeted start date of March 1, 2015, between AHS and Christenson Communities Ltd. for the funding of the operation of 60 Supportive Living spaces at the Red Deer facility, 40 Supportive Living Spaces at the Rocky Mountain House facility, and 23 Supportive Living Spaces at the Valleyview facility, each for a 30 year term and in the maximum overall term amount of \$232,427,198;
- (e) the agreement with targeted start date of January 1, 2016, between AHS and Covenant Health for the funding of the operation of 250 Supportive Living spaces at the Redstone facility, for a 30 year term and in the maximum term amount of \$356,863,540;
- (f) the agreement with targeted start date of February 28, 2014, between AHS and Covenant Health for the funding of the operation of 100 Supportive Living spaces at the Holy Cross facility, for a 30 year term and in the maximum term amount of \$135,400,000;
- (g) the agreement with targeted start date of February 28, 2014, between AHS and Covenant Health for the funding of the operation of 100 Supportive Living spaces at the Villa Marie facility, for a 30 year term and in the maximum term amount of \$135,400,000;
- (h) the agreement with targeted start date of March 15, 2015, between AHS and Multi Generational Housing Inc. for the funding of the operation of 120 Supportive Living spaces at the Multi-generational Housing and Community Centre, for a 30 year term and in the maximum term amount of \$171,294,500;
- (i) the agreement with targeted start date of April 1, 2015, between AHS and Park Place Seniors Living for the funding of the operation of 80 Supportive Living spaces at the Medicine Hat facility, for a 30 year term and in the maximum term amount of \$114,196,333;
- (j) the agreement between AHS and Points West Living Red Deer for the funding of the operation of 60 Supportive Living spaces at the Red Deer facility in the maximum term amount of \$115,200,000 (assuming a 30 year term) or equivalent given the term negotiated upon;
- (k) the agreement with targeted start date of March 1, 2015, between AHS and Reichmann Seniors Housing for the funding of the operation of 72 Supportive Living spaces at the Calgary facility, for a 30 year term and in the maximum term amount of \$107,921,326;
- (I) the agreement with targeted start date of October 1, 2013, between AHS and Sagewood Seniors Community Inc. for the funding of the operation of 100 Supportive Living and Long Term Care beds at the Strathmore facility, for a 30 year term and in the maximum term amount of \$167,176,844;

- (m) the agreement with targeted start date of May 2, 2014, between AHS and the Chinese Christian Wing Kei Nursing Home Association for the funding of the operation of 95 Supportive Living spaces at the Greenview facility, for a 30 year term and in the maximum term amount of \$120,400,000; and
- (n) the agreement with targeted start date of May 2, 2014, between AHS and Eldercare Communities Ltd. & Continuum Health Care Holdings Ltd. for the funding of the operation of 108 Supportive Living spaces, for a 20 year term and in the maximum term amount of \$90,400,000.

3. [OA13-12] Appointment of Trustees to Health Foundations

Appointments of trustees are made to foundations and health trusts that fall under the *Regional Health Authorities Act* based on recommendations made to the Official Administrator.

5. [OA13-14] Internal Audit Charter

The mandate of the AHS Internal Audit function is to provide independent and objective assurance to senior management and the Official Administrator, regarding the operation of AHS and its wholly owned subsidiaries: Calgary Laboratory Services Ltd., Capital Care Group Inc., and Carewest. The Internal Audit Charter sets out the authority and responsibility of AHS' Internal Audit Department, Management and the Official Administrator. The Internal Audit Charter was approved in June 2013 and has been amended to confirm the Chief Audit Executive's reporting relationship to the Official Administrator.

- 2. Management of AHS is hereby authorized and directed to take all such other action as management considers necessary or advisable in order to give full effect to the foregoing.
