1. [OA14-23] Appointment of Cancer Provincial Advisory Council Members

The amended Bylaw for the Cancer Provincial Advisory Council requires the Official Administrator to appoint advisory council members.

WHEREAS this Resolution is enacted pursuant to Section 11(2)(a) of the Regional Health Authorities Act (Alberta) and the Order of the Minister of Health of Alberta effective November 17, 2014, appointing Dr. Carl Amrhein as the Official Administrator of AHS (the "Official Administrator");

3. [OA14-26] Official Administrator Delegation of the Authority to Execute Amending Agreements Between AHS, Covenant Health and Medical Imaging Consultants

AHS and Covenant Health contract with Medical Imaging Consultants for radiology services in the Edmonton Zone and wish to enter into amendments with respect to the Agreement.

WHEREAS this Resolution is enacted pursuant to Section 11(2)(a) of the *Regional Health Authorities Act* (Alberta) ("RHA") and the Order of the Minister of Health of Alberta (the "Minister") effective November 17, 2014, appointing Dr. Carl Amrhein as the Official Administrator of AHS (the "Official Administrator");

AND WHEREAS pursuant to Section 6(2) of the RHA, the regional health authority may delegate any power or duty conferred or imposed on it under the RHA or any other provincial legislation, to a committee of the regional health authority, to any of its employees, officers or agents or to a community health council;

AND WHEREAS the AHS Delegation of Authority and Establishment of Controls for Commitments Policy (the "Policy"), delegates and establishes appropriate limits on commitments to be approved and executed by the President and Chief Executive Officer of AHS (the "CEO") on behalf of AHS;

AND WHEREAS on November 6, 2014, the Official Administrator approved AHS entering into the following amending agreements (the "Amending Agreements") to the current agreement with Medical Imaging Consultants (MIC) for radiology services in the Edmonton: (i) Amending Agreement dated 7th of November 2012 with respect to the East Edmonton Health Centre; (ii) Amending Agreement dated 1st of April 2013 with respect to the Edmonton Remand Centre; and (iii) Amending Agreement dated January 1, 2014 with respect to After Hours.

AND WHEREAS the value of the Amending Agreements exceed the CEO's Approved Limits (as defined in the Policy);

NOW THEREFORE BE IT RESOLVED THAT:

1. The CEO is hereby authorized to execute on behalf of AHS the Amending Agreements.
