Use of Mobile Electronic Devices when Patients are on Contact and Droplet Precautions including COVID-19

1. Cleaning and disinfection of mobile electronic devices

Devices taken into patient rooms with <u>contact and droplet precautions</u> in place, including COVID-19 patients, are cleaned and disinfected following manufacturer's instructions before contact with a patient or patient's environment; after contact with a patient or patient's environment; and when the device is visibly soiled. Refer to <u>link</u> for examples of mobile electronic devices.

- 1.1 Before contact with a patient or patient's environment, e.g., room entry:
 - Clean and disinfect the device with a ready-to-use disinfectant wipe following instructions in Section 2. The following disinfectants are commonly used for cleaning and disinfecting mobile electronic devices: CaviWipes®, Virox RTU®, Accel®, Oxivir® and Percept Wipe®;
 - Perform hand hygiene, and <u>don</u> personal protective equipment (PPE) required for <u>contact and droplet</u> precautions, i.e., gown, mask, face shield/eye protection, and gloves.
- 1.2 After contact with a patient or patient's environment, e.g., exit from the room:
 - Place the device outside the immediate patient environment, e.g. 2 metres away from patient, on a counter, near door, and within reach from where staff will <u>doff</u>;
 - Open door (move curtain if needed);
 - Begin doffing PPE outside the immediate patient's environment, i.e., at least 2 metre away from the patient;
 - o Remove gloves, perform hand hygiene, remove gown, and perform hand hygiene again.
 - Put on new, clean gloves accessed from glove box;
 - Clean and disinfect the device following instructions in Section 2;
 - Exit room and place the cleaned and disinfected device on a clean surface or pass to a colleague.
 - Complete doffing of PPE.
 - Remove gloves, perform hand hygiene, remove face shield/eye protection, remove mask, and perform hand hygiene again.

2. Device cleaning and disinfection instructions

Perform hand hygiene, don gloves and disinfect device with a ready-to-use disinfectant wipe:

- Wipe all the surfaces of the device including its protective case or cover if applicable, from the leastsoiled to the most-soiled areas;
- Keep the surface wet for the minimum contact time recommended by the manufacturer;
- Put the device on a clean surface and allow it to dry completely;
- Remove gloves and perform hand hygiene.

Notes: Do not use alcohol-based hand rub (ABHR) to disinfect devices as it is not intended to be used as an equipment disinfectant and it may cause damage to the device.
