



## Connect Care Launch 7 CMIO Area Trainers

### Overview

Connect Care Area Trainers (ATs) are users of the Connect Care clinical information system (CIS) in one or more areas of clinical specialization. ATs are trained and supported to instruct and support peers (in their own or similar clinical area or specialty) in safe and acceptable CIS use while promoting transformation and clinical improvement.

Accordingly, they work closely with zone medical leadership and co-report to the North Zone Associate Chief Medical Information Officer (ACMIO). It is possible for Physician Design Leads, MILs, other physician roles or physician contributors to extend their Connect Care commitment by adding an AT role for a larger overall FTE allocation.

ATs are guided by CMIO Provincial Training team who have provincial scope and responsibility for design of curriculum content that can be adapted to clinical area and facility needs.

**AHS is recruiting for ATs for the Connect Care launch on November 5, 2023, from Launch 7 sites, specifically:**

- Anesthesia (1)
- Diagnostic Imaging (1)
- Surgery (1)
- Rural Medicine (1)

### Expectations

ATs should be interested in training their colleagues and are excited to positively contribute to the further refinement of physician training.

#### Getting Trained (Approximately 64 hours):

ATs receive training specific to their role and to develop proficiency with Connect Care to facilitate productive communications and interactions. Additionally, they participate in two teach backs as preparation for training delivery. Training will tentatively start in early April 2023.

#### Delivering Training (Approximately 60 hours):

ATs train End Users and Super Users for their roles as well as delivering formal training to physicians on Connect Care including basic training, personalization, and optimization. ATs teach approximately 4 classes per stream (Basic, Personalization, Optimization). Classes are in person and/or virtual.

#### Launch Support (Optional 36 hours):

ATs are some of the most effective individuals to have for launch support due to their extensive knowledge of the system and experience in training their colleagues. ATs may be asked by their clinical department to provide launch support.

### Compensation

There are a variety of payment arrangements for Physicians (Clinical ARPs, AMHSP and other relationships). As a result, there can be some variation to how physicians are compensated for the Area Trainer role. A Fee for Service physician can expect:

- \$8,000 after completing training
- \$125/hr for each of the following activities scheduled and approved by the AHS CMIO team as in-person/onsite or technology-enabled virtual training delivery or support:
  - Delivering AHS scheduled classroom training sessions (approximately 60 hours)
  - Providing AHS scheduled launch support or delivering additional AHS scheduled classroom training sessions (approximately 36 hours)
- An Area Trainer can provide a maximum of 136 training delivery or launch support hours as part of their contract
  - Once the maximum number of hours has been reached a contract amendment is required to provide any additional hours of training or support
