Nursing Student FAQs

This FAQ document is intended for placing coordinators at Post Secondary Institutes (PSIs) that place students in AHS (and its affiliates) sites – all sites are live on Connect Care. Starting with the Fall 2025 semester, nursing student roles will be streamlined and condensed.

Bridge Nursing Students

Students in Bridge Nursing programs will use the new nursing student roles; so use the same <u>role</u> <u>assignment guidelines</u> as you would for non-bridging nursing students.

Footcare Nursing Students

These students will use Nursing Student - Continuing Care Facility Living.

Orthotech Nursing Students

The new nursing student roles will not change role assignment/s for these types of students. They will continue to use their standard Orthotech role assignment/s [Orthopaedics Nurse (Ambulatory) & Emergency Nurse (if required)].

Wound Care Nursing Students

There is no change to role assignment/s for these students. They will continue to use their standard Wound Care Team role assignment/s.

Undergraduate Nursing Employees (UNEs)

There is no change to role assignment/s for these students and role assignments are completed by their manager, not their PSI.

Instructor Role Assignment

There is no change to role assignment/s for instructors; they still require the same role as their students, so assign them to the new roles. There is also no change to the .e2 process for instructors.

Instructors Co-Signing Medications of Students

There is no change to this practice and the instructor will still be able to Co-Sign their students' medications with using the new nursing student roles.

Multi-Function Units

MFU roles will only be granted for Final Practicum nursing students. Non-Final Practicum nursing students will use the new nursing student roles and won't have access to OpTime tools as previously granted as this is too much security access. Please see the <u>PITS form</u> for the MFU tabs for more instructions.

Short Notice Acceptances

Submit a PITS form for any odd late acceptances rather than relying on the S/A (Security Access) Listing Report. Still submit the S/A Listing Report for the bulk of students that were accepted.

Scheduling Cadence

Base training Instructor Led Training (ILTs) will most likely occur at the beginning of each week with the corresponding practicum specific ILT near the middle or end of the week.

ICU/CVICU/PICU/NICU Roles

Final practicum nursing students going to an ICU will need to take an extra eLearning, as per usual training processes for these departments, and the eLearning is usually completed near the end of the classroom ILT with the extra time left over – hence, no extra AHS computer will be booked for these students.

Non-Nursing Student Roles

There are no changes to non-nursing student roles.
