PRINCIPLES

- 1. As protocols are being developed and approved, the Long Term Care Pharmacy and Therapeutics Committee (The Committee) undertakes to follow a standardized process for development. Approval will follow the "Criteria for Listing Drug Products on the LTC Formulary" protocol. This will be based on evidence-based practice relevant to the long term care institutional setting as far as possible and may include consultation with experts in the area, recognizing that there are a number of factors that are considered in protocol development in addition to information from experts.
- 2. Individuals who disagree with an evidenced-based protocol will follow a prescribed challenge pathway.
- 3. The Committee is recognized as being the body to receive challenges to protocols.

CHALLENGES

The following components are required for challenges to be considered by the Committee. The challenge:

- 1. Will clearly identify if the full protocol is being challenged, or if the challenge refers to a particular aspect of the protocol;
- 2. Will suggest the requested/proposed criteria change (i.e. what the criteria would be if the challenge is accepted);
- 3. Needs to identify the scientific rationale for the challenge, with supporting evidence for the requested change. Evidence should be pertinent to the LTC setting as possible;
- 4. Must identify any potential conflicts of interest from the individual submitting the challenge.

Note: challenges may or may not be successful.

PROCESS

- 1. Challenge received on behalf of the Committee.
- 2. Challenge reviewed by pharmacy consultant on behalf of the Committee both for completion of required elements and for the scientific rationale for the requested change.
- 3. Challenge taken to the Committee for decision as to next steps. Individual would need to attend a meeting, and if not available to negotiate with Chair to attend at a more convenient time.
- 4. The challenge may be addressed by the Committee at the meeting where it is first brought forward. If not, steps will be recommended by the Committee to address the challenge. A timeline for this work will be established.
- 5. Steps recommended by the Committee are undertaken.
- Results of the further steps recommended by the Committee are brought back to the Committee for decision.
- 7. Should the challenge be unsuccessful, an option to appeal through the Medical Advisory Board (MAB) may be considered. This would require consultation with the Chair of MAB.
- 8. Repeat challenges will require explicit new evidence to support a change in protocol and will generally not be accepted within 6 months of a Committee decision on any previous challenge.
