Message to Nurse Practitioners

Attention Nurse Practitioners,

Please be advised that the Nurse Practitioner Standards of Practice for Medical Assistance in Dying were approved on December 8, 2016 through an Order in Council as announced by the College and Association of Registered Nurses of Alberta (CARNA).

CARNA has collaborated with Alberta Health, Alberta Health Services, the College of Physicians and Surgeons of Alberta and the Alberta College of Pharmacists to develop a regulatory framework for medical assistance in dying. This framework is aligned with the new law (the Act to amend the Criminal Code and to make related amendments to other Acts - Medical Assistance in Dying) and is legally sound, safe and consistent with the amended Criminal Code. The framework includes additional provincial safeguards for consistency and patient safety.

What does this mean for Nurse Practitioners (NPs) in Alberta?

It is important for those NPs, who wish to participate as assessing or providing practitioners, to familiarize themselves with the new Nurse Practitioner Standards of Practice for Medical Assistance in Dying. NP guidelines will also be available in early 2017.
