Workplace Health and Safety (WHS) seasonal immunization (influenza and COVID-19) clinics are open for walk-ins and appointments. Here are ways to get immunized:

- Book or call 811 to make an appointment.
- Attend a WHS walk-in clinic. See the schedule.
- Check for a roving cart at your facility or a site champion on your unit.

You also have the option to receive an mRNA KP.2 COVID-19 vaccine at participating WHS clinics. If you have a copy of your last COVID-19 immunization records, please bring them with you to your appointment.
