New health-related Ministries created; new Ministers appointed: Message from the CMO

Last week, the Government of Alberta <u>announced</u> changes to Cabinet that will help us continue to move forward in healthcare refocusing. The key change is that the Ministry of Health has now been split into two new Ministries:

- Ministry of Primary and Preventative Health Services (Minister Adriana LaGrange)
- 2) Ministry of Hospital and Surgical Services (Minister Matt Jones)

There is now a Ministry and Minister responsible for each of the four new provincial health agencies. You can see more information about which Ministry will be responsible for various programs and organizations in the AHS CEO's message, posted on Insite.

As a fellow physician and leader, I want to acknowledge that I know continuous changes and uncertainty can create stress. I'm also hearing many of you feel communication and engagement could be stronger during this time.

I'm also committed to more direct engagement with you, and I'm looking at opportunities to visit more AHS facilities across the province to meet with you in person. We can all continue to focus on ensuring our patients have the high-quality care they need, when and where they need it. 

Transfer of positions to Provincial Health Agencies

Yesterday, AHS' Interim CEO and President, Andre Tremblay, announced that over 4,300 positions will transfer from AHS to Assisted Living Alberta (ALA) and Primary Care Alberta (PCA) effective July 1, 2025. This includes our Medical Officer of Health colleagues, who will transfer to the Ministry of Primary Care and Preventative Health Services.

Most of the Public Health portfolio will move out of AHS to PCA, and public health policy, health marketing and public health inspections will transfer to the Ministry of Primary and Preventive Health in the future.

Other key changes include:

- Aspects of chronic disease management and some Indigenous wellness is moving to PCA.
- Provincial Seniors Health and Continuing Care, including the Continuing Care funding team and CPSM team, are moving to ALA.
