# North Zone: Virtual Emergency Physician Pilot Works to Address Service Disruptions

Launched Jan. 20 in the North Zone (NZ), the Virtual Emergency Physician (VEP) pilot aims to address Emergency Department (ED) service disruptions when physicians are not physically on-site. Piloted in Hinton, Edson, Beaverlodge, Lac La Biche and Elk Point, the following successes have already been achieved:

- Over four months, provided 1,740 hours of coverage (97.3 per cent of hours without a physician on-site).
- In three months, nearly 600 patients seen that would have otherwise needed alternative options for care.
- Preliminary reports found patients generally accept the program with an average effectiveness rating of 7.0 (on a scale of 1 to 10).

This innovative program addresses a critical need to maintain safe and effective clinical care in our rural and remote communities. VEP has been extended through December 2025 and NZ expansion is being planned, along with consideration for other zones.

## Hospital-based decision-making to expand

The province will be strengthening healthcare by giving hospitals more control to make timely, practical decisions that improve patient care. The move toward hospital-based leadership will bring more decision-making to the front lines, empowering hospital leaders to make real-time decisions based on what's happening on the ground and respond to patient needs as they arise. Acute Care Alberta will support coordination across the system and AHS will continue to play a key role focusing on operations across hospitals and oversight of hospital-based leadership.

This new hospital leadership structure will be introduced in November, with full implementation across Alberta by Summer 2026. These changes are part of ongoing healthcare refocusing efforts and the transition of Alberta Health Services to a hospital service provider. Read more.

# Modernized registration processes for IMGs to strengthen Alberta's physician workforce

On Wednesday, June 18, the College of Physicians & Surgeons of Alberta (CPSA) announced steps they are taking to strengthen Alberta's physician workforce by streamlining registration processes for international medical graduates (IMGs) from approved jurisdictions.

Physicians who hold credentials from <u>approved jurisdictions</u> (Ireland, Australia, United Kingdom and United States of America) that have been deemed as substantially equivalent to Canadian standards will now be eligible for full licensure without undergoing additional assessments. This builds on the success of CPSA's Accelerated Jurisdiction Route (now renamed the <u>Approved Jurisdiction Route</u>), which has consistently demonstrated strong physician performance and safe patient outcomes.

From an AHS perspective, we see potential for an increase in applicants from approved jurisdictions. It also gives us opportunities to consider targeted recruitment campaigns that showcase Alberta's simplified licensing.

See page 5 of the list for a summary of updates:

- Substantial NIOSH-driven changes with more than 30 reclassifications
- Addition of two (2) new medications as REPRODUCTIVE
- Prioritized reclassification of one (1) medication (semaglutide) from KNOWN to POTENTIAL

Note: All information systems are updated. Teams and program areas are required to implement these changes.
