Leadership Message

Reflecting on 2025 – A message from Dr. Peter Jamieson

As the end of the year quickly approaches, I want to take a moment to say thank you for your unwavering commitment to patient care and your continued resilience during times of change.

This year has continued to bring new challenges and changes, not just in our workplace, but in Alberta and around the world. I know this can be tiring and has had an impact on all of us in some way. I appreciate each of you for continuing to show up for your patients and for each other.

As I look ahead to 2026, I'm anticipating that we will enter a period of nailing down stable ways of working administratively and getting past a lot of the uncertainty of the last year. I'm grateful to work with each of you, as a fellow physician first and foremost, and as your Chief Medical Officer second, and I look forward to continuing our work together in the year ahead. 2026 Annual Information Verification & Attestation arrives in January

On Jan. 19, 2026, all medical staff will receive an email with a link to your 2026 Annual Information Verification & Attestation (AIVA). This link will be sent to your healthcare organization email address (e.g., Alberta Health Services, Recovery Alberta, Alberta Precision Labs, etc.).

You will also receive a text message from AHS and a courtesy email to your preferred alternative email address on file, if you have one, to remind you to log in to your organizational email to complete your AIVA.

When you log in to complete your AIVA, please use your full email address and current network password. For example, if you work at AHS, please use John.Doe@albertahealthservices.ca, not John.Doe@ahs.ca.

Please note that even if you don't primarily work in an AHS facility, affiliation with the medical staff is required to access various services, including IT systems like Connect Care. AHS Provincial Medical Affairs is facilitating this process for all medical staff, as usual.

All medical staff are required to complete the AIVA annually, as outlined in the [Medical Staff Bylaws & Rules](#). The process is quick and should take only about five minutes to complete. The deadline is Feb. 14, 2026.

Review updated Hazardous Medication List

The [Hazardous Medication List](#) is updated and posted on [Insite](#). See page five of the list for a summary of updates:

- Removal of one medication, due to the changes to how NIOSH evaluates hazardous medications as published in the NIOSH 2024 List;
- Reclassification of four medications, due to the changes to how NIOSH evaluates hazardous medications; and
- Addition of eight new medications

Note: All information systems are updated. Teams and program areas are required to implement these changes.

New Connect Care digital workflow for Medical Certificate of Death

As of Dec. 9, 2025, Connect Care supports a digital workflow for completing death certificates. This minimizes double-data-entry by taking advantage of

information abstracted from a patient's chart.

Prescribers can use the "Certificate of Death" section of the Discharge as Deceased navigator to initiate a "chart abstraction" that will set up a certificate using the patient's health data. An interface opens in the chart sidebar where the clinician validates abstracted data and adds information not already pulled from the deceased patient's chart.
