

ORDER OF AN EXECUTIVE OFFICER

To: Govind and Vidya Reddy; Stacy Martin; Tim Closs; 1058250 Alberta Ltd

RE: Those housing premises located in Lethbridge, Alberta and municipally described as:
273 Mt. Crandell Crescent W.

WHEREAS I, an **Executive Officer** of **Alberta Health Services**, have inspected the above noted premises pursuant to the provisions of the Public Health Act, RSA 2000, c. P-37, as amended;

AND WHEREAS such inspection disclosed that the following conditions exist in and about the above noted premises which are or may become injurious or dangerous to the public health or which might hinder in any manner the prevention or suppression of disease, namely:

- a. The tenant has installed a temporary plywood barrier on the stairs to prevent the children from falling through the rails. This is only a temporary solution as the guardrails are still not built to code.

AND WHEREAS such inspection disclosed that the following breaches of the Public Health Act and the Housing Regulation, Alberta Regulation 173/99, and the Minimum Housing and Health Standards exist in and about the above noted premises, namely:

- a. The tenant has installed a temporary plywood barrier on the stairs to prevent the children from falling through the rails. This is only a temporary solution as the guardrails are still not built to code which is in contravention of section III(3)(c) of the Minimum Housing and Health Standards which states that: Inside or outside stairs or porches including all treads, risers, supporting structural members, rails, guards and balconies, shall be maintained in good repair and shall comply with the requirements of the Alberta Building Code or a Professional Engineer design.

NOW THEREFORE, I hereby **ORDER** and **DIRECT**:

1. That the Owner immediately undertake and diligently pursue the completion of the following work in and about the above noted premises, namely:
 - a. Ensure guardrails are securely installed according to the Alberta Building Code.
2. The work referred to in paragraph 1 shall be completed by March 1st, 2017.

The above conditions were noted at the time of inspection and may not necessarily reflect all deficiencies. You are advised that further work may be required to ensure full compliance with the Public Health Act and regulations, or to prevent a public health nuisance.
