

## ORDER OF AN EXECUTIVE OFFICER NOTICE OF CLOSURE

**To:** 1st Class Innovative Childcare Solutions Inc.

**RE:** The social care facility located in Calgary, Alberta and municipally described as:

1<sup>st</sup> Class Child Care Shawnessy – Main daycare room

504-303 Shawville Blvd SE

WHEREAS I, an Executive Officer of Alberta Health Services, have inspected the above noted premises pursuant to the provisions of the Public Health Act, RSA 2000, c. P-37, as amended;

**AND WHEREAS** such inspection disclosed that the following conditions exist in and about the above noted premises which are or may become injurious or dangerous to the public health or which might hinder in any manner the prevention or suppression of disease, namely:

a. There was an individual with a confirmed case of significant enteric illness that attended the childcare facility during period of communicability.

**AND WHEREAS**, by virtue of the foregoing, the above noted premises are hereby declared to be **Closed**.

NOW THEREFORE, I hereby **ORDER** and **DIRECT**:

- 1. That the Owner immediately Close the above noted premises.
- 2. That the Owner immediately undertake and diligently pursue the completion of the following work in and about the above noted premises, namely:
  - a. Provide all information, samples and any other items required by the Medical Officer of Health and/or Public Health Inspector.
  - b. Conduct a thorough cleaning and disinfection of the facility in accordance with the direction of the Public Health Inspector.
- 3. That until such time as the work referred to above is completed to the satisfaction of Alberta Health Services, and approval to reopen is granted by the Medical Officer of Health/Executive Officer; the above noted premises shall remain closed.

The above conditions were noted at the time of inspection and may not necessarily reflect all deficiencies. You are advised that further work may be required to ensure full compliance with the Public Health Act and regulations, or to prevent a public health nuisance.
