

**ORDER OF AN EXECUTIVE OFFICER
UNFIT FOR HUMAN HABITATION
ORDER TO VACATE
ON OR BEFORE SEPTEMBER 9, 2026**

And To: All Occupant(s) of the following Housing premises:

RE: Those housing premises located in Calgary, Alberta and municipally described as:
3355 Dovercliffe Road SE - Garage

I, an **Executive Officer of Alberta Health Services**, have inspected the above noted premises pursuant to the provisions of the **Public Health Act**, RSA 2000, c. P-37, as amended;

By virtue of the violations noted below, the above noted premises are hereby declared to be **Unfit for Human Habitation**.

I hereby **ORDER** and **DIRECT**:

1. That all occupants vacate the above noted premises.
2. That the Owner(s) ensure all Occupants vacate the above noted premises on or before September 9, 2026.
3. That the Owner(s) immediately undertake and diligently pursue the completion of the following work in and about the above noted premises, namely:
 - a. Immediately cease allowing the use of the garage for sleeping and / or living purposes until it is brought into full compliance with the Minimum Housing and Health Standards.
4. That until such time as the work referred to above is completed to the satisfaction of an Executive Officer of Alberta Health Services; the above noted premises shall remain vacant and secure from unauthorized entry.

These required actions are necessary given the presence of the following conditions identified during inspection which are or may become injurious or dangerous to the public health or which might hinder in any manner the prevention or suppression of disease, in contravention of the Public Health Act, namely:

- a. There was evidence that the garage was being used for sleeping and living purposes. A person was observed residing in the garage, which contained a tent, clothing, food items, furniture, and other personal belongings. The garage had unfinished walls and flooring, lacked a smoke detector, and was not equipped with plumbing, electricity, or heating. In addition, there were no kitchen or washroom facilities available.

These observed public health nuisance conditions identified during inspection are violations of the Housing Regulation, Alberta Regulation 173/99, and the Minimum Housing and Health Standards, namely:

- a. There was evidence that the garage was being used for sleeping and living purposes. A person was observed residing in the garage, which contained a tent, clothing, food items, furniture, and other personal belongings. The garage had unfinished walls and flooring, lacked a smoke detector, and was not equipped with plumbing, electricity, or heating. In addition, there were no kitchen or washroom facilities available. This is a contravention of section 5(2) of the Housing Regulation, 2001 which states that: No person shall cause or permit any condition in housing premises that is or may become injurious or dangerous to the public health, including any condition that may hinder in any way the prevention or suppression of disease.
