

ORDER OF AN EXECUTIVE OFFICER

To: Eva Yuen
"the Owner"

RE: Those housing premises located in Calgary, Alberta and municipally described as:
7703 41 Avenue NW – Common Area

WHEREAS I, an **Executive Officer of Alberta Health Services**, have inspected the above noted premises pursuant to the provisions of the Public Health Act, RSA 2000, c. P-37, as amended;

AND WHEREAS such inspection disclosed that the following conditions exist in and about the above noted premises which are or may become injurious or dangerous to the public health or which might hinder in any manner the prevention or suppression of disease, namely:

- a. The eaves troughs had holes in them resulting in water leaking through them and down the exterior of the building.
- b. The siding was damaged or missing in several sections of the building.
- c. There was an uncovered electrical panel on the front of the house with many live wires hanging from it.

AND WHEREAS such inspection disclosed that the following breaches of the Public Health Act and the Housing Regulation, Alberta Regulation 173/99, and the Minimum Housing and Health Standards exist in and about the above noted premises, namely:

- a. The eaves troughs had holes in them resulting in water leaking through them and down the exterior of the building. This is a contravention of section III(2)(a) of the Minimum Housing and Health Standards which states that: The roof and exterior cladding of walls shall be maintained in a waterproof, windproof and weatherproof condition.
- b. The siding was damaged or missing in several sections of the building. This is a contravention of section III(2)(a) of the Minimum Housing and Health Standards which states that: The roof and exterior cladding of walls shall be maintained in a waterproof, windproof and weatherproof condition.
- c. There was an uncovered electrical panel on the front of the house with many live wires hanging from it. This is a contravention of section IV(11) of the Minimum Housing and Health Standards which states that: Every housing premises shall be supplied with electrical service. Outlets, switches and fixtures shall be properly installed and shall be maintained in a good and safe working condition.

NOW THEREFORE, I hereby **ORDER** and **DIRECT**:

1. That the Owner immediately undertake and diligently pursue the completion of the following work in and about the above noted premises, namely:
 - a. Repair eaves troughs so all water drains away from the building.
 - b. Repair siding.

- c. Repair the electrical panel on the front of the house. Contract the services of a qualified electrician to make repairs and provide documentation to an Executive Officer of Alberta Health Services. Documentation must indicate repairs have been done in accordance with recommendations of electrician.

2. The work referred to in paragraph 1 shall be completed by March 14, 2022.

The above conditions were noted at the time of inspection and may not necessarily reflect all deficiencies. You are advised that further work may be required to ensure full compliance with the Public Health Act and regulations, or to prevent a public health nuisance.
