

ORDER OF AN EXECUTIVE OFFICER UNFIT FOR HUMAN HABITATION ORDER TO VACATE

To: Ronaldo Felix

And To: All Occupant(s) of the following Housing premises: 925 Marcombe Drive NE – Shed 1

RE: Those housing premises located in Calgary, Alberta and municipally described as:

925 Marcombe Drive NE - Shed 1

WHEREAS I, an Executive Officer of Alberta Health Services, have inspected the above noted premises pursuant to the provisions of the Public Health Act, RSA 2000, c. P-37, as amended;

AND WHEREAS such inspection disclosed that the following conditions exist in and about the above noted premises which are or may become injurious or dangerous to the public health or which might hinder in any manner the prevention or suppression of disease, in contravention of the Public Health Act and the Nuisance and General Sanitation Regulation, Alberta Regulation 243/2003 namely:

a. There was evidence that the Shed labelled #1 was being used for sleeping and living purposes. Inside, there was a bed, clothing, furniture, and personal belongings. The shed had no smoke detector, no proper heating, no plumbing, no kitchen, and no washroom facilities.

AND WHEREAS such inspection disclosed that the following breaches of the Housing Regulation, Alberta Regulation 173/99, and the Minimum Housing and Health Standards exist in and about the above noted premises, namely:

a. There was evidence that the Shed labelled #1 was being used for sleeping and living purposes. Inside, there was a bed, clothing, furniture, and personal belongings. The shed had no smoke detector, no proper heating, no plumbing, no kitchen, and no washroom facilities. This is a contravention of section 5(2) of the Housing Regulation, 2001 which states that: No person shall cause or permit any condition in housing premises that is or may become injurious or dangerous to the public health, including any condition that may hinder in any way the prevention or suppression of disease.

AND WHEREAS, by virtue of the foregoing, the above noted premises are hereby declared to be **Unfit for Human Habitation**.

NOW THEREFORE, I hereby **ORDER** and **DIRECT**:

1. That the Owner(s) takes all steps necessary to ensure all Occupants vacate the above noted premises on or before September 20, 2025.

- 2. That the Owner(s) immediately undertake and diligently pursue the completion of the following work in and about the above noted premises, namely:
 - a. Immediately cease allowing the use of the Shed #1 for sleeping and / or living purposes until it is brought into full compliance with the Minimum Housing and Health Standards.
- 3. That until such time as the work referred to above is completed to the satisfaction of an Executive Officer of Alberta Health Services; the above noted premises shall remain vacant and secure from unauthorized entry.

The above conditions were noted at the time of inspection and may not necessarily reflect all deficiencies. You are advised that further work may be required to ensure full compliance with the Public Health Act and regulations, or to prevent a public health nuisance.
