

ORDER OF AN EXECUTIVE OFFICER NOTICE OF CLOSURE

To: Jasmine Leiva Garcia
"the owner"

RE: The personal services facility located in Banff, Alberta and municipally described as: Banff Lash Extensions, Unit 224 Tunnel Building, 405 Spray Avenue, Banff, Alberta

WHEREAS I, an **Executive Officer** of **Alberta Health Services**, have inspected the above noted premises pursuant to the provisions of the Public Health Act, RSA 2000, c. P-37, as amended;

AND WHEREAS such inspection disclosed that the following conditions exist in and about the above noted premises which are or may become injurious or dangerous to the public health or which might hinder in any manner the prevention or suppression of disease, namely:

- a. Living quarters (habitable room) is being used for lash extension services, and esthetic services are not separated from living quarters.
- b. Approved disinfectants and processes were not available for cleaning and disinfecting equipment. Soap and water only were being used to clean instruments between clients.
- c. There is no stainless steel sink for cleaning and disinfecting instruments.
- d. Adhesives are not being used according to the manufacturer's directions on the label, including providing patch tests to the client.

AND WHEREAS such inspection disclosed that the following breaches of the Public Health Act and the Personal Services Regulation, Alberta Regulation 20/2003 exist in and about the above noted premises, namely:

- a. Living quarters (habitable room) is being used for lash extension services, and esthetic services are not separated from living quarters. This is in contravention of Section 5 of the Personal Services Regulation, which states: "A personal service facility must be located so that the service provision areas are separate from any sleeping, dining, bathing, washroom or food preparation areas."
- b. Approved disinfectants and processes were not available for cleaning and disinfecting equipment. Soap and water only were being used to clean instruments between clients. This is in contravention of Section 6(2) of the Personal Service Regulation, which states, "All reusable equipment and instruments must be cleaned, disinfected, or sterilized in accordance with the Standards and Guidelines referred to in Section 8".
- c. There is no stainless steel sink for cleaning and disinfecting instruments. This is in contravention of Section 4(1) of the Personal Services Regulation, which states, : "A personal service facility in which . . . aesthetic services are provided must be equipped with a sink that is stainless steel, supplied with soap and hot air dryers or single service towels in suitable dispensers, not in a washroom, only used for washing hands or cleaning equipment, only used by the staff and clients of the personal service facility, and in or readily accessible to the service provision area."

- d. Adhesives are not being used according to the manufacturer's directions on the label, including providing patch tests to the client. This is in contravention of Section 13(4) of the Health Guidelines and Standards for Esthetic Services which state: "All chemicals shall be used in accordance with the manufacturer instructions and in a manner to prevent hazard to the client."

AND WHEREAS, by virtue of the foregoing, the above noted premises are hereby declared to be **Closed**.

NOW THEREFORE, I hereby **ORDER** and **DIRECT**:

1. That the Owner immediately close the above noted premises.
2. That the Owner immediately undertake and diligently pursue the completion of the following work in and about the above noted premises, namely:
 - a) Do not use this premises to provide esthetics services until it is approved by an Alberta Health Services Executive Officer.
3. That until such time as the work referred to above is completed to the satisfaction of an Executive Officer of Alberta Health Services; the above noted premises shall remain closed.

The above conditions were noted at the time of inspection and may not necessarily reflect all deficiencies. You are advised that further work may be required to ensure full compliance with the Public Health Act and regulations, or to prevent a public health nuisance.
