

ORDER OF AN EXECUTIVE OFFICER NOTICE OF CLOSURE

RE: The mobile food establishment located in Calgary, Alberta and municipally described as:
Eggie Street – CNT-979
26 Arbour Butte Way NW, Calgary, AB

WHEREAS I, an **Executive Officer of Alberta Health Services**, have inspected the above noted premises pursuant to the provisions of the Public Health Act, RSA 2000, c. P-37, as amended;

AND WHEREAS such inspection disclosed that the following conditions exist in and about the above noted premises which are or may become injurious or dangerous to the public health or which might hinder in any manner the prevention or suppression of disease, namely:

- a. The waffle mix inside the residential cooler was measured at 16°C. The cooler's surface temperature was also measured at 16°C.
- b. The two waffle mixes were stored at room temperature and were measured at 23°C.
- c. The bleach-water sanitizer solution was measured above 200 ppm.
- d. The meatballs in the hot-holding unit were measured at 36°C.

AND WHEREAS such inspection disclosed that the following breaches of the Public Health Act and the Food Regulation, Alberta Regulation 31/2006 and the Food Retail and Foodservices Code exist in and about the above noted premises, namely:

- a. The waffle mix inside the residential cooler was measured at 16°C. The cooler's surface temperature was also measured at 16°C. This is in contravention of the Food Regulation, Alberta Regulation 31/2006, section 25(1)(a)(b), which states that: All high-risk food must be stored, displayed and transported at a temperature of not more than 4°C or such a higher temperature, or not less than 60°C or such lower temperature as an executive officer stipulates under subsection (4).
- b. The two waffle mixes were stored at room temperature and were measured at 23°C. This is in contravention of the Food Regulation, Alberta Regulation 31/2006, section 25(1)(a)(b), which states that: All high-risk food must be stored, displayed and transported at a temperature of not more than 4°C or such a higher temperature, or not less than 60°C or such lower temperature as an executive officer stipulates under subsection (4).
- c. The bleach-water sanitizer solution was measured above 200 ppm. This is in contravention of the Food Regulation, Alberta Regulation 31/2006, section 23(1)(a), which states that: All food used or to be used in a commercial food establishment must be protected from contamination.

- d. The meatballs in the hot-holding unit were measured at 36°C. This is in contravention of the Food Regulation, Alberta Regulation 31/2006, section 25(1)(a)(b), which states that: All high-risk food must be stored, displayed and transported at a temperature of not more than 4°C or such a higher temperature, or not less than 60°C or such lower temperature as an executive officer stipulates under subsection (4).

AND WHEREAS, by virtue of the foregoing, the above noted premises are hereby declared to be **Closed**.

NOW THEREFORE, I hereby **ORDER** and **DIRECT**:

1. That the Owner immediately close the above noted premises.
2. That the Owner immediately undertake and diligently pursue the completion of the following work in and about the above noted premises, namely:
 - a. Ensure that all high-risk food items are stored at a temperature of not more than 4°C or such a higher temperature, or not less than 60°C or such lower temperature.
 - b. Create a written plan for temperature monitoring of high-risk food products.
 - c. Ensure that the bleach-water sanitizer solution is maintained at a concentration between 100 ppm and 200 ppm.
3. That until such time as the work referred to above is completed to the satisfaction of an Executive Officer of Alberta Health Services; the above noted premises shall remain closed.

The above conditions were noted at the time of inspection and may not necessarily reflect all deficiencies. You are advised that further work may be required to ensure full compliance with the Public Health Act and regulations, or to prevent a public health nuisance.
