

ORDER OF AN EXECUTIVE OFFICER NOTICE OF CLOSURE

To: Janet Mendoza
"the Owner"

RE: The food establishment located in Calgary, Alberta and municipally described as:
Janet Mendoza Food
1509 24 Avenue NW

WHEREAS I, an **Executive Officer of Alberta Health Services**, have inspected the above noted premises pursuant to the provisions of the Public Health Act, RSA 2000, c. P-37, as amended;

AND WHEREAS such inspection disclosed that the following breaches of the Public Health Act and the Food Regulation, Alberta Regulation 31/2006 and the Food Retail and Foodservices Code exist in and about the above noted premises, namely:

- a. Operating a food establishment without a valid food handling permit from Alberta Health Services. This contravenes section 3(1)(a)(b) of the Food Regulation, AR 31/2006 which states that: No person shall operate a food establishment unless the person is an operator who holds a valid and subsisting permit for the operation of the food establishment, and the food establishment is identified on the permit as approved by the regional health authority that issued the permit.

AND WHEREAS, by virtue of the foregoing, the above noted premises are hereby declared to be **Closed**.

NOW THEREFORE, I hereby **ORDER** and **DIRECT**:

1. That the Owner immediately close the above noted premises.
2. That the Owner immediately undertake and diligently pursue the completion of the following work in and about the above noted premises, namely:
 - a. Immediately cease all food preparation, storage, and sale activities.
 - b. Remove all advertisements including online advertisements
 - c. Obtain written approval from Alberta Health Services for the use of a permitted food facility and apply for a food handling permit.
3. That until such time as the work referred to above is completed to the satisfaction of an Executive Officer of Alberta Health Services; the above noted premises shall remain closed.

The above conditions were noted at the time of inspection may not necessarily reflect all deficiencies. You are advised that further work may be required to ensure full compliance with the Public Health Act and regulations, or to prevent a public health nuisance.
