

## ORDER OF AN EXECUTIVE OFFICER NOTICE OF CLOSURE

**To:** MJTJ Ltd.

**RE:** The food establishment located in Calgary, Alberta and municipally described as:

Jugo Juice

2108 - 11300 Rocky Ridge Road NW

WHEREAS I, an Executive Officer of Alberta Health Services, have inspected the above noted premises pursuant to the provisions of the Public Health Act, RSA 2000, c. P-37, as amended;

**AND WHEREAS** such inspection disclosed that the following conditions exist in and about the above noted premises which are or may become injurious or dangerous to the public health or which might hinder in any manner the prevention or suppression of disease, namely:

a. There was an unknown contaminant in the water supply servicing this facility, as indicated by green color, metallic taste, and reports of illness in the adjoining facility. As such, we cannot be assured of the potability of the water at this time.

**AND WHEREAS** such inspection disclosed that the following breaches of the Public Health Act and the Food Regulation, Alberta Regulation 31/2006 and the Food Retail and Foodservices Code exist in and about the above noted premises, namely:

a. There was an unknown contaminant in the water supply servicing this facility, as indicated by green color, metallic taste, and reports of illness in the adjoining facility. As such, we cannot be assured of the potability of the water at this time. This is in contravention of section 17(1)(f)(i) of the Food Regulation AR 31/2006, which states that: "An operator must ensure that, before operation of the commercial food establishment commences, the commercial food establishment is supplied with hot and cold running water that is safe for human consumption and available in quantities sufficient to meet the needs of the commercial food establishment."

**AND WHEREAS**, by virtue of the foregoing, the above noted premises are hereby declared to be **Closed**.

NOW THEREFORE, I hereby **ORDER** and **DIRECT**:

1. That the Owner immediately close the above noted premises.

- 2. That the Owner immediately undertake and diligently pursue the completion of the following work in and about the above noted premises, namely:
  - a. Ensure that the water line servicing the facility has been assessed and remediated.
  - b. Undertake thorough flushing of all the water lines in the facility and as well as any equipment serviced by those lines as directed by an executive officer.
  - c. Discard any products made with the suspected water supply.
  - d. Provide chemical water samples for assessment.
- 3. That until such time as the work referred to above is completed to the satisfaction of an Executive Officer of Alberta Health Services and the water testing has shown to be satisfactory; the above noted premises shall remain closed.

The above conditions were noted at the time of inspection and may not necessarily reflect all deficiencies. You are advised that further work may be required to ensure full compliance with the Public Health Act and regulations, or to prevent a public health nuisance.
