

ORDER OF AN EXECUTIVE OFFICER NOTICE OF CLOSURE

RE: The food establishment located in Calgary, Alberta and municipally described as:
La Fritanga
8534 19 Avenue SE Calgary, Alberta T2A 0M8

WHEREAS I, an **Executive Officer** of **Alberta Health Services**, have inspected about the above noted premises pursuant to the provisions of the Public Health Act, RSA 2000, c. P-37, as amended;

AND WHEREAS such inspection disclosed that the following conditions exist in and about the above noted premises which are or may become injurious or dangerous to the public health or which might hinder in any manner the prevention or suppression of disease, namely:

- a. A food business was operating without a valid food handling permit.

AND WHEREAS such inspection disclosed that the following breaches of the Public Health Act and the Food Regulation, Alberta Regulation 31/2006 and the Food Retail and Foodservices Code exist in and about the above noted premises, namely:

- a. A food business was being operated without a valid food handling permit. This is in contravention of the Food Regulation AR31/2006, section 3(1)(a)(b), which states that: No person shall operate a food establishment unless the person is an operator who holds a valid and subsisting permit for the operation of the food establishment, and the food establishment is identified on the permit as approved by the regional health authority that issued the permit

AND WHEREAS, by virtue of the foregoing, the above noted premises are hereby declared to be **Closed**.

NOW THEREFORE, I hereby **ORDER** and **DIRECT**:

1. That the Owner immediately close the above noted premises.
2. That the Owner immediately undertake and diligently pursue the completion of the following work in and about the above noted premises, namely:

- a. Cease all unapproved food operations until such time that a valid food handling permit is issued by an Executive Officer with Alberta Health Services.
 - b. Remove all advertisements promoting the business.
3. That until such time as the work referred to above is completed to the satisfaction of an Executive Officer of Alberta Health Services; the above noted premises shall remain closed.

The above conditions were noted at the time of inspection and may not necessarily reflect all deficiencies. You are advised that further work may be required to ensure full compliance with the Public Health Act and regulations, or to prevent a public health nuisance.
