

## ORDER OF AN EXECUTIVE OFFICER NOTICE OF CLOSURE

**RE:** The mobile food establishment located in Calgary, Alberta and municipally described as:

LuLu Produce- Unpermitted mobile food facility with Alberta license plate CXL-6333

WHEREAS I, an Executive Officer of Alberta Health Services, have inspected the above noted premises pursuant to the provisions of the Public Health Act, RSA 2000, c. P-37, as amended;

**AND WHEREAS** such inspection disclosed that the following conditions exist in and about the above noted premises which are or may become injurious or dangerous to the public health or which might hinder in any manner the prevention or suppression of disease, namely:

- a. Transporting raw shell eggs, tofu, and raw chicken without cold holding equipment that ensures that perishable foods are maintained at 4 degrees Celsius or colder.
- b. Food was stored directly on the ground of the parking lot in a manner that could contaminate the food products.

**AND WHEREAS** such inspection disclosed that the following breaches of the Public Health Act and the Food Regulation, Alberta Regulation 31/2006 and the Food Retail and Foodservices Code exist in and about the above noted premises, namely:

- a. Transporting raw shell eggs, tofu, and raw chicken without cold holding equipment that ensures that perishable foods are maintained at 4 degrees Celsius or colder which is in contravention of section 26 of the Food Regulation, AR 31/2006 which states that a commercial food establishment that is a food transportation, storage or distribution unit must be operated in a manner that does not create a nuisance.
- b. Operating without a valid and subsisting food handling permit from Alberta Health Services, which is in contravention of section 3(1) (a) (b) of the Food Regulation, AR 31/2006 which states that no person shall operate a food establishment unless the person is an operator who holds a valid and subsisting permit for the operation of the food establishment, and the food establishment is identified on the permit as approved by the regional health authority that issued the permit.
- c. Food was stored directly on the ground of the parking lot in a manner that could contaminate the food products, which is in contravention of section 23(1)(a)(b) of the Food Regulation, AR 31/2006 which states that: All food used or to be used in a commercial food establishment must be protected from contamination and handled in a sanitary manner.

**AND WHEREAS**, by virtue of the foregoing, the above noted premises are hereby declared to be **Closed**.

## NOW THEREFORE, I hereby **ORDER** and **DIRECT**:

- 1. That the Owner immediately close the above noted premises.
- 2. That the Owner immediately undertake and diligently pursue the completion of the following work in and about the above noted premises, namely:
  - a. Ensure that all high-risk food is stored, displayed and transported in a manner that does not create a nuisance.
  - b. Obtain a valid food handling permit from Alberta Health Services.
  - c. Store and display food at least 15 cm off the ground in a sanitary manner that protects all food products from contamination.
- 3. That until such time as the work referred to above is completed to the satisfaction of an Executive Officer of Alberta Health Services; the above noted premises shall remain closed.

The above conditions were noted at the time of inspection and may not necessarily reflect all deficiencies. You are advised that further work may be required to ensure full compliance with the Public Health Act and regulations, or to prevent a public health nuisance.
