

ORDER OF AN EXECUTIVE OFFICER NOTICE OF CLOSURE

To: Saheb Alabadi

RE: The food establishment located in Calgary, Alberta and municipally described as:

Mediterranean Halal Meats & Deli

A - 3917 17 Avenue SE

WHEREAS I, an Executive Officer of Alberta Health Services, have inspected the above noted premises pursuant to the provisions of the Public Health Act, RSA 2000, c. P-37, as amended;

AND WHEREAS such inspection disclosed that the following conditions exist in and about the above noted premises which are or may become injurious or dangerous to the public health or which might hinder in any manner the prevention or suppression of disease, namely:

- a. There is evidence that uninspected meat has been purchased and sold at this location.
- b. Operating without a valid permit, as the company listed as the owner is no longer in operation.

AND WHEREAS such inspection disclosed that the following breaches of the Public Health Act and the Food Regulation, Alberta Regulation 31/2006, the Food Retail and Foodservices Code and the Nuisance and General Sanitation Regulation Alberta Regulation 243/2003 exist in and about the above noted premises, namely:

- a. There is evidence that uninspected meat has been purchased and sold at this location. This contravenes section 22(1) of the Food Regulation AR 31/2006, which states that: Subject to this section, a commercial food establishment must obtain all food that is liable under law to inspection by the Government of Canada or Alberta or by an agency of either from a source that is subject to inspection by that entity.
- b. Operating without a valid permit, as the company listed as the owner is no longer in operation which is in contravention of section 3(1) (a) (b) which states that no person shall operate a food establishment unless the person is an operator who holds a valid and subsisting permit for the operation of the food establishment, and the food establishment is identified on the permit as approved by the regional health authority that issued the permit

AND WHEREAS, by virtue of the foregoing, the above noted premises are hereby declared to be **Closed**.

NOW THEREFORE, I hereby **ORDER** and **DIRECT**:

- 1. That the Owner immediately close the above noted premises.
- 2. That the Owner immediately undertake and diligently pursue the completion of the following work in and about the above noted premises, namely:
 - a. Provide evidence to the satisfaction of an Alberta Health Services, Executive Officer that all prepared, processed and displayed food is from an approved source and provide a list of all food suppliers.
 - b. Provide a copy of all the receipts/invoices for all meat products from the past 3 months to the Executive Officer.
 - c. Clean and sanitize all food contact surfaces including all equipment used within the facility. Provide a written summary to the Executive Officer of all the cleaning and sanitizing activities including a complete list of all equipment that was cleaned and sanitized and the chemicals/products used to clean and sanitize.
 - d. Ensure all products placed on hold by the executive officer remain on hold until the conclusion of the investigation.
 - e. Obtain a valid food handling permit from Alberta Health Services.
- That until such time as the work referred to above is completed to the satisfaction of an Executive Officer of Alberta Health Services; the above noted premises shall remain closed.

The above conditions were noted at the time of inspection and may not necessarily reflect all deficiencies. You are advised that further work may be required to ensure full compliance with the Public Health Act and regulations, or to prevent a public health nuisance.
