

ORDER OF AN EXECUTIVE OFFICER NOTICE OF CLOSURE

RE: The food establishment located in Calgary, Alberta and municipally described as:

Mi Ranchito Tacobus - CGY-1181 31 Del Ray Cres NE Calgary

WHEREAS I, an Executive Officer of Alberta Health Services, have inspected the above noted premises pursuant to the provisions of the Public Health Act, RSA 2000, c. P-37, as amended;

AND WHEREAS such inspection disclosed that the following conditions exist in and about the above noted premises which are or may become injurious or dangerous to the public health or which might hinder in any manner the prevention or suppression of disease, namely:

- a. There was no hot water in the mobile food truck.
- b. There was insufficient water pressure in the mobile food truck.
- c. Food handlers were not adequately washing their hands.
- d. The preparation cooler in the mobile food truck measured 7°C.
- e. The standing fridge in the mobile food truck measured 15.5°C. The display thermometer recorded 60°F.

AND WHEREAS such inspection disclosed that the following breaches of the Public Health Act and the Food Regulation, Alberta Regulation 31/2006 and the Food Retail and Foodservices Code exist in and about the above noted premises, namely:

- a. There was no hot water in the mobile food truck. This is in contravention of the Food Regulation AR 31/2006 section 17(1)(f)(i), which states that: An operator must ensure that, before operation of the commercial food establishment commences, the commercial food establishment is supplied with hot and cold running water that is safe for human consumption and available in quantities sufficient to meet the needs of the commercial food establishment.
- b. There was insufficient water pressure in the mobile food truck. This is in contravention of the Food Regulation AR 31/2006 section 17(1)(f)(i), which states that: An operator must ensure that, before operation of the commercial food establishment commences, the commercial food establishment is supplied with hot and cold running water that is safe for human consumption and available in quantities sufficient to meet the needs of the commercial food establishment.

 - c. Food handlers were not adequately washing their hands. This is in contravention of the Food Regulation AR 31/2006 section 30(1)(d), which states that: A food handler must wash hands as often as necessary to prevent the contamination of food or food areas,
 - d. The preparation cooler in the mobile food truck measured 7°C. This is in contravention of the Food Regulation AR 31/2006 section 25(1)(a)(b), which states that: All high-risk food must be stored, displayed and transported at a temperature of not more than 4°C or such higher temperature, or not less than 60°C or such lower temperature as an executive officer stipulates under subsection (4).
 - e. The standing fridge in the mobile food truck measured 15.5°C. The display thermometer recorded 60°F. This is in contravention of the Food Regulation AR 31/2006 section 25(1)(a)(b), which states that: All high-risk food must be stored, displayed and transported at a temperature of not more than 4°C or such higher temperature, or not less than 60°C or such lower temperature as an executive officer stipulates under subsection (4).

AND WHEREAS, by virtue of the foregoing, the above noted premises are hereby declared to be **Closed**.

NOW THEREFORE, I hereby **ORDER** and **DIRECT**:

- 1. That the Owner immediately close the above noted premises.
- 2. That the Owner immediately undertake and diligently pursue the completion of the following work in and about the above noted premises, namely:
 - a. Equip the mobile food truck with hot running water supplied to all sinks with sufficient pressure to accommodate handwashing and dishwashing.
 - b. Ensure an adequate supply of hot and cold potable water is available in the mobile food truck.
 - c. Ensure that everyone working in the food truck washes their hands often enough to prevent contamination of food or food areas.
 - d. Ensure the temperature of the preparation cooler measures 4°C or less at all times.
 - e. Ensure the temperature of the standing fridge measures 4°C or less at all times.
- 3. That until such time as the work referred to above is completed to the satisfaction of an Executive Officer of Alberta Health Services; the above noted premises shall remain closed.

The above conditions were noted at the time of inspection and may not necessarily reflect all deficiencies. You are advised that further work may be required to ensure full compliance with the Public Health Act and regulations, or to prevent a public health nuisance.
