

ORDER OF AN EXECUTIVE OFFICER NOTICE OF CLOSURE

RE: The mobile food establishment located in Calgary, Alberta and municipally described as:

Mi Ranchito Taco Bus - CGY-2024 31 Del Ray Crescent NE Calgary

WHEREAS I, an **Executive Officer** of **Alberta Health Services**, have received a report about the above noted premises pursuant to the provisions of the Public Health Act, RSA 2000, c. P-37, as amended;

AND WHEREAS such report disclosed that the following conditions exist in and about the above noted premises which are or may become injurious or dangerous to the public health or which might hinder in any manner the prevention or suppression of disease, namely:

- a. The bacteriological water sample collected on 12/09/2025 tested positive for Total Coliforms.
- b. The bacteriological water sample collected on 17/09/2025 tested positive for Total Coliforms.

AND WHEREAS such report disclosed that the following breaches of the Public Health Act and the Food Regulation, Alberta Regulation 31/2006 and the Food Retail and Foodservices Code exist in and about the above noted premises, namely:

- a. The bacteriological water sample collected on 12/09/2025 tested positive for Total Coliforms. This is in contravention of the Food Regulation AR 31/2006 section 17(1)(f)(i), which states that: An operator must ensure that, before operation of the commercial food establishment commences, the commercial food establishment is supplied with hot and cold running water that is safe for human consumption and available in quantities sufficient to meet the needs of the commercial food establishment.
- b. The bacteriological water sample collected on 17/09/2025 tested positive for Total Coliforms. This is in contravention of the Food Regulation AR 31/2006 section 17(1)(f)(i), which states that: An operator must ensure that, before operation of the commercial food establishment commences, the commercial food establishment is supplied with hot and cold running water that is safe for human consumption and available in quantities sufficient to meet the needs of the commercial food establishment.

AND WHEREAS, by virtue of the foregoing, the above noted premises are hereby declared to be **Closed**.

NOW THEREFORE, I hereby **ORDER** and **DIRECT**:

- 1. That the Owner immediately close the above noted premises.
- 2. That the Owner immediately undertake and diligently pursue the completion of the following work in and about the above noted premises, namely:
 - a. Shock chlorinate the water system for 24 hours and then flush the water system of all chlorinated water.
 - b. Fill the tank with potable water and submit another sample to the Provincial Laboratory.
- 3. That until such time as the work referred to above is completed to the satisfaction of an Executive Officer of Alberta Health Services; and the water sample in paragraph 2 (b) is satisfactory, the above noted mobile food establishment shall remain closed.

The above conditions were noted at the time of receipt of the report and may not necessarily reflect all deficiencies. You are advised that further work may be required to ensure full compliance with the Public Health Act and regulations, or to prevent a public health nuisance.
