

ORDER OF AN EXECUTIVE OFFICER NOTICE OF CLOSURE

RE: The "pool" located in Calgary, Alberta and municipally described as:
Redox Wellness – Cold Plunge Tub
345 – 3425 22 Street SW

WHEREAS I, an **Executive Officer** of **Alberta Health Services**, have inspected the above noted premises pursuant to the provisions of the Public Health Act, RSA 2000, c. P-37, as amended;

AND WHEREAS such inspection disclosed that the following breaches of the Public Health Act and the Public Swimming Pools Regulation, Alberta Regulation 204/2014 and the Pool Standards there under exist in and about the above noted premises, namely:

- a. The Facility did not obtain a valid permit to operate the cold plunge tub. This is in contravention of Section 7(1) of the Public Swimming Pools Regulation, which states that "No person shall operate a pool without a permit issued in accordance with this section."

AND WHEREAS, by virtue of the foregoing, the above noted premises are hereby declared to be **Closed**.

NOW THEREFORE, I hereby **ORDER** and **DIRECT**:

1. That the Owner immediately close the above noted premises.
2. That the Owner immediately undertake and diligently pursue the completion of the following work in and about the above noted premises, namely:
 - a. Drain the cold plunge tub and ensure it is not accessible to the public
 - b. Submit a written application for a permit to AHS, and obtain a valid permit
3. That until such time as the work referred to above is completed to the satisfaction of an Executive Officer of Alberta Health Services; the above noted premises shall remain closed.

The above conditions were noted at the time of inspection and may not necessarily reflect all deficiencies. You are advised that further work may be required to ensure full compliance with the Public Health Act and regulations, or to prevent a public health nuisance.
