

ORDER OF AN EXECUTIVE OFFICER NOTICE OF CLOSURE

To: Marko Zelcer

"the Owner"

RE: The food establishment located in Nanton, Alberta and municipally described as:

Rickshaw Hot Dogs - CGY-1082 2121 21 Street, Nanton, Alberta

WHEREAS I, an Executive Officer of Alberta Health Services, have inspected the above noted premises pursuant to the provisions of the Public Health Act, RSA 2000, c. P-37, as amended;

AND WHEREAS such inspection disclosed that the following breaches of the Public Health Act and the Food Regulation, Alberta Regulation 31/2006 and the Food Retail and Foodservices Code exist in and about the above noted premises, namely:

a. Operating without using a required base of operation(s) associated with your mobile unit for cleaning and sanitizing, food handling and storage. This is in contravention of the Alberta Public Health Act, Food Regulation Section 9(4) which states: "An operator must ensure that the terms and conditions of the permit are not contravened" and in contravention of the Alberta Public Health Act, Food Regulation Section 22(1) which states: "A commercial food establishment must obtain all food that is liable under law to inspection by the Government of Canada or Alberta or by an agency of either from a source that is subject to inspection by that entity".

AND WHEREAS, by virtue of the foregoing, the above noted premises are hereby declared to be **Closed**.

NOW THEREFORE, I hereby **ORDER** and **DIRECT**:

- 1. That the Owner immediately close the above noted premises.
- 2. That the Owner immediately undertake and diligently pursue the completion of the following work in and about the above noted premises, namely:
 - a. Obtain a signed AHS Permission to Use an Approved Food Establishment form from an operating food facility/kitchen in Calgary, AB for your mobile base of operations.
 - b. Ensure all the food preparation, food storage, cleaning and sanitizing activities all occur exclusively at the registered approved base of operation.

3. That until such time as the work referred to above is completed to the satisfaction of an Executive Officer of Alberta Health Services; the above noted premises shall remain closed.

The above conditions were noted at the time of inspection and may not necessarily reflect all deficiencies. You are advised that further work may be required to ensure full compliance with the Public Health Act and regulations, or to prevent a public health nuisance.
