

## ORDER OF AN EXECUTIVE OFFICER NOTICE OF CLOSURE

**RE:** The "pool" located in Cochrane, Alberta and municipally described as:

The Cave Sauna Day Spa - Cold Plunge Tub

316 3 Street W Cochrane, AB T4C 1Z6

WHEREAS I, an Executive Officer of Alberta Health Services, have inspected the above noted premises pursuant to the provisions of the Public Health Act, RSA 2000, c. P-37, as amended;

**AND WHEREAS** such inspection disclosed that the following breaches of the Public Health Act and the Public Swimming Pools Regulation, Alberta Regulation 204/2014 and the Pool Standards there under exist in and about the above noted premises, namely:

a. The Facility did not obtain a valid permit to operate the cold plunge tub. This is in contravention of Section 7(1) of the Public Swimming Pools Regulation, which states that "No person shall operate a pool without a permit issued in accordance with this section."

**AND WHEREAS**, by virtue of the foregoing, the above noted premises are hereby declared to be **Closed**.

NOW THEREFORE, I hereby **ORDER** and **DIRECT**:

- 1. That the Owner immediately close the above noted premises.
- 2. That the Owner immediately undertake and diligently pursue the completion of the following work in and about the above noted premises, namely:
  - a. Drain the cold plunge tub immediately and ensure it is not accessible to the public.
  - b. Submit a written application for a permit to AHS, Environmental Public Health, and obtain a valid permit in accordance with the regulation, prior to any future installation or operation of cold plunge pool.
- 3. That until such time as the work referred to above is completed the above noted premises shall remain closed.
