

## FOOD HANDLING PERMIT NOTICE OF SUSPENSION

**RE:** The establishment located in Calgary, Alberta and municipally described as:

The Chaat Bar & Parontha Place  
2030 - 6004 Country Hills Boulevard NE

This notice is to inform you that your food handling permit has been suspended pursuant to s 11(b) of the *Food Regulation*, Alta Reg 31/2006, due to the following reasons:

1. The food establishment was confirmed to be operating on October 04, 2025, in violation of a Closure Order issued October 03, 2025.
2. The food establishment issued a Closure Order on October 03, 2025, for non-compliance with the Food Regulation. Many of the violations noted were recurring issues, such as temperature abuse of food, improper storage of food, obstructed and ill-equipped handwashing sinks, lack of food safety knowledge, and dirty and/or damaged surfaces, equipment and utensils throughout.
3. The food establishment did not cease operation of an outdoor food stall as required in the inspection report dated September 22, 2025.

In order for the suspension to be lifted, the following criteria must be met:

1. Attend an administrative review to discuss and address repeat violations found in the food establishment. Details are in the paragraph below.
2. You must demonstrate full compliance with the requirements of the Closure Order issued on October 03, 2025. Compliance will be verified during an onsite reinspection by an AHS Executive Officer.

The permit suspension will be evaluated at an administrative review on **October 21, 2025**. To facilitate this review, please confirm your attendance at **2:00pm** on October 21, at the Alberta Health Services Southport Office, 10101 Southport Road SW, Calgary, Alberta.
