

ORDER OF AN EXECUTIVE OFFICER NOTICE OF CLOSURE

RE: The food establishment located in Foothills County, Alberta and municipally described as:

The Saskatoon Farm

80181 338 Avenue East, Foothills, Alberta

WHEREAS I, an Executive Officer of Alberta Health Services, have inspected the above noted premises pursuant to the provisions of the Public Health Act, RSA 2000, c. P-37, as amended;

AND WHEREAS such inspection disclosed that the following conditions exist in and about the above noted premises which are or may become injurious or dangerous to the public health or which might hinder in any manner the prevention or suppression of disease, namely:

a. The food facility currently serving this location is under investigation due to a significant enteric illness outbreak. There is a possibility of illness spread to and within The Saskatoon Farm.

AND WHEREAS, by virtue of the foregoing, the above noted premises are hereby declared to be **Closed**.

NOW THEREFORE, I hereby **ORDER** and **DIRECT**:

- 1. That the Owner immediately close the above noted premises.
- 2. That the Owner immediately undertake and diligently pursue the completion of the following work in and about the above noted premises, namely:
 - a. Provide all information, samples and any other items required by the Public Health Inspector
 - b. Conduct a thorough cleaning and disinfection of the facility in accordance with the direction of the Public Health Inspector.
 - c. Provide a written re-opening plan for the facility which includes a description of the cleaning and disinfection performed and a staffing plan approved by the Public Health Inspector.

- d. Submit a written water monitoring plan to the satisfaction of the Public Health Inspector.
- 3. That until such time as the work referred to above is completed to the satisfaction of an Executive Officer of Alberta Health Services, the above noted premises shall remain closed.

The above conditions were noted at the time of inspection and may not necessarily reflect all deficiencies. You are advised that further work may be required to ensure full compliance with the Public Health Act and regulations, or to prevent a public health nuisance.
