

ORDER OF AN EXECUTIVE OFFICER NOTICE OF PUBLIC ACCESS CLOSURE

To: Taylor Bradley
"the Owner"

RE: Those premises located in Claresholm, Alberta and municipally described as:
Willow Creek Indoor Playground
4209 3 Street Claresholm, Alberta T0L 0T0

WHEREAS I, an **Executive Officer of Alberta Health Services**, have inspected the above noted premises pursuant to the provisions of the Public Health Act, RSA 2000, c. P-37, as amended;

AND WHEREAS the Chief Medical Officer of Health (CMOH) has issued the Record Of Decision – CMOH Order 25-2020 of the Public Health Act, in response to a public health emergency,

AND WHEREAS such inspection disclosed that the following conditions exist in and about the above noted premises in contravention of the above order of the CMOH and which are or may become injurious or dangerous to the public health or which might hinder in any manner the prevention or suppression of disease, namely:

- a. An indoor children's play center was open to the public.

AND WHEREAS, by virtue of the above order of the CMOH, the above noted premises are hereby prohibited from allowing public access into the children's play center portion of the business.

NOW THEREFORE, I hereby **ORDER** and **DIRECT**:

1. That the owner IMMEDIATELY CLOSE the children's play center portion of the business to the public.
2. The children's play center portion of the business shall remain closed to the public until such time that this Order is rescinded by an Executive Officer of Alberta Health Services.

The above conditions were noted at the time of inspection and may not necessarily reflect all deficiencies. You are advised that further work may be required to ensure full compliance with the Public Health Act and regulations, or to prevent a public health nuisance.
