

ORDER OF AN EXECUTIVE OFFICER CLOSED FOR TENANT ACCOMMODATION PURPOSES ORDER TO VACATE

To: Charlotte Wagner "the Owner"

And To: All Occupant(s) of the following Housing premises:

RE: Those housing premises located in Red Deer, Alberta and municipally described as: 3929 51A Street – Basement Suite

WHEREAS I, an Executive Officer of Alberta Health Services, have inspected the above noted premises pursuant to the provisions of the Public Health Act, RSA 2000, c. P-37, as amended;

AND WHEREAS such inspection disclosed that the following conditions exist in and about the above noted premises which are or may become injurious or dangerous to the public health or which might hinder in any manner the prevention or suppression of disease, namely:

- The dimensions of the bedroom windows do not comply with minimum egress requirements as they (two bedrooms in the basement) were measured at 12.6 inches by 16.5 inches.
- b. Mold was observed on the bottom 5 inches of the walls in the room adjacent to the laundry machines.
- c. The front door weatherstripping was noted to be in disrepair.

AND WHEREAS such inspection disclosed that the following breaches of the Public Health Act and the Housing Regulation, Alberta Regulation 173/99, and the Minimum Housing and Health Standards exist in and about the above noted premises, namely:

- a. The dimensions of the bedroom windows (two bedrooms in the basement) were measured at 12.6 inches by 16.5 inches. This is in contravention of Section 3(b)(ii) of the Minimum Housing and Health Standards which states that: "Windows referred to in section 3(b)(i) shall provide unobstructed openings with areas not less than 0.35m² (3.8ft²), with no dimension less than 380 mm (15")."
- b. Mold was observed on the bottom 5 inches of the walls in the room adjacent to the laundry machines. This is in contravention of Section 1(c) of the Minimum Housing and Health Standards which states that: "Building materials that have been damaged or show evidence of rot or other deterioration shall be repaired or replaced."
- c. The front door weatherstripping was noted to be in disrepair. This is in contravention of Section 2(b)(i) of the Minimum Housing and Health Standards which states that: "All windows and exterior doors shall be; maintained in good repair, free of cracks and weatherproof."

AND WHEREAS, by virtue of the foregoing, the above noted premises are hereby declared to be **Closed for Tenant Accommodation Purposes**.

NOW THEREFORE, I hereby ORDER and DIRECT:

- 1. That the occupants vacate the above noted premises on or before August 2, 2024.
- 2. That the Owner immediately undertake and diligently pursue the completion of the following work in and about the above noted premises, namely:
 - a. Repair the windows in the two bedrooms so they provide unobstructed openings with areas not less than 0.35m² (3.8ft²) and no dimension less than 380 mm (15").
 - b. Ensure walls which have mold present are remediated as per current accepted guidelines.
 - c. Ensure the front door weatherstripping is repaired or replaced.
- 3. That until such time as the work referred to above is completed to the satisfaction of an Executive Officer of Alberta Health Services; the above noted premises shall remain closed for tenant accommodation purposes.

The above conditions were noted at the time of inspection and may not necessarily reflect all deficiencies. You are advised that further work may be required to ensure full compliance with the Public Health Act and regulations, or to prevent a public health nuisance.
