

## ORDER OF AN EXECUTIVE OFFICER UNFIT FOR HUMAN HABITATION ORDER TO VACATE

To: Shelly Nault 300326 Alberta Ltd. Kamal Hamdon Mohammed Hamdon Ahmed Hamdon "the Owners"

**And To:** All Occupant(s) of the following Housing premises:

**RE:** Those housing premises located in Drayton Valley, Alberta and municipally described as: 5644 50 Street – Unit 93.

WHEREAS I, an Executive Officer of Alberta Health Services, have inspected the above noted premises pursuant to the provisions of the Public Health Act, RSA 2000, c. P-37, as amended;

**AND WHEREAS** such inspection disclosed that the following conditions exist in and about the above noted premises which are or may become injurious or dangerous to the public health or which might hinder in any manner the prevention or suppression of disease, in contravention of the Public Health Act and the Nuisance and General Sanitation Regulation, Alberta Regulation 243/2003 namely:

- a. The housing premises utility connections have been disconnected.
- b. The housing premises has extensive structural damage.

**AND WHEREAS** such inspection disclosed that the following breaches of the Housing Regulation, Alberta Regulation 173/99, and the Minimum Housing and Health Standards exist in and about the above noted premises, namely:

- a. The housing premises utility connections have been disconnected. This is in contravention of section 3(1)(b)(ii)(iii) of the Housing Regulation, AR 173/99, which states: "an owner shall ensure that the occupants of the housing premises are supplied with adequate heating facilities that are capable of maintaining a habitable indoor temperature, running hot and cold water that is safe for human consumption."
- b. The housing premises has extensive structural damage. This condition is in contravention of section III (1)(a) of the Minimum Housing and Health Standards, which states: "The housing premises shall be structurally sound."

**AND WHEREAS**, by virtue of the foregoing, the above noted premises are hereby declared to be **Unfit for Human Habitation**.

NOW THEREFORE, I hereby **ORDER** and **DIRECT**:

- 1. That the Owner(s) takes all steps necessary to ensure all Occupants vacate the above noted premises on or before June 10, 2025.
- 2. That the Owner(s) immediately undertake and diligently pursue the completion of the following work in and about the above noted premises, namely:
  - a. Immediately secure the premises from unauthorized entrance.
  - b. Repair damage caused to the structure and ensure the home is in good repair and structurally sound.
- 3. That until such time as the work referred to above is completed to the satisfaction of an Executive Officer of Alberta Health Services; the above noted premises shall remain vacant and secure from unauthorized entry.

The above conditions were noted at the time of inspection and may not necessarily reflect all deficiencies. You are advised that further work may be required to ensure full compliance with the Public Health Act and regulations, or to prevent a public health nuisance.
