

ORDER OF AN EXECUTIVE OFFICER

RE: Those housing premises located in Red Deer, Alberta and municipally described as:

Unit 2, 5816 58 Avenue

WHEREAS I, an Executive Officer of Alberta Health Services, have inspected the above noted premises pursuant to the provisions of the Public Health Act, RSA 2000, c. P-37, as amended;

AND WHEREAS such inspection disclosed that the following conditions exist in and about the above noted premises which are or may become injurious or dangerous to the public health or which might hinder in any manner the prevention or suppression of disease, namely:

- a. There was evidence of a mice infestation. Dead mice were found in metal mouse traps in the basement and mice droppings were observed on the kitchen area countertop, in the oven storage drawer, and in one room located on the first level of the premises. There is an insect nest/hive present in the basement area above the foundation wall.
- b. Personal belongings and other items were observed throughout the home limiting mobility, narrowing of pathways through the home, and obstructing access to exits in the event of a fire.

AND WHEREAS such inspection disclosed that the following breaches of the Public Health Act, the Nuisance and General Sanitation Regulation, Alberta Regulation 243/2003, the Housing Regulation, Alberta Regulation 173/99, and the Minimum Housing and Health Standards exist in and about the above noted premises, namely:

- a. There was evidence of a mice infestation. Dead mice were found in metal mouse traps in the basement and mice droppings were observed on the kitchen area countertop, in the oven storage drawer, and in one room located on the first level of the premises. There is an insect nest/hive present in the basement area above the foundation wall. These conditions are in contravention of Section 16(a) of the Minimum Housing and Health Standards, which states: "The owner shall ensure that the housing premises are free of insect and rodent infestations."
- b. Personal belongings and other items were observed throughout the home limiting mobility, narrowing of pathways through the home, and obstructing access to exits in the event of a fire. This condition is in contravention of Section 2(1) of the Nuisance and General Sanitation Regulation which states that: "No person shall create, commit or maintain a nuisance."

NOW THEREFORE, I hereby **ORDER** and **DIRECT**:

1. That the Owner immediately undertake and diligently pursue the completion of the following work in and about the above noted premises, namely:

- a. Ensure that a qualified pest control company is hired, and corrective measures are taken to remediate the mice and insect infestation. You must also ensure documented evidence (i.e. invoices with corrective measures taken), detailing the remedial work that has been completed, is provided to an Executive Officer with Alberta Health Services.
- b. Ensure all areas of the premises are accessible to the pest control company in order for the company to conduct an inspection and take necessary remedial action to address the mice/insect infestation (i.e. Relocate the tenant's personal belongings and other items, as needed). This is also required to ensure emergency egress is not obstructed.
- 2. The work referred to in paragraph 1 shall be completed by February 26, 2024.

The above conditions were noted at the time of inspection and may not necessarily reflect all deficiencies. You are advised that further work may be required to ensure full compliance with the Public Health Act and regulations, or to prevent a public health nuisance.
