

ORDER OF AN EXECUTIVE OFFICER NOTICE OF CLOSURE

RE: The "pool" located in Red Deer County, Alberta and municipally described as:

Hampton Inn & Suites – Swimming Pool, 128 Leva Avenue

WHEREAS I, an Executive Officer of Alberta Health Services, have inspected the above noted premises pursuant to the provisions of the Public Health Act, RSA 2000, c. P-37, as amended;

AND WHEREAS such inspection disclosed that the following conditions exist in and about the above noted premises which are or may become injurious or dangerous to the public health or which might hinder in any manner the prevention or suppression of disease, namely:

a. The suction outlet cover for the east main drain is damaged with a broken corner.

AND WHEREAS such inspection disclosed that the following breaches of the Public Health Act and the Public Swimming Pools Regulation, Alberta Regulation 204/2014 and the Pool Standards there under exist in and about the above noted premises, namely:

a. The suction outlet cover for the east main drain is damaged with a broken corner. This is in contravention of Section 9.6.2 of the Alberta Health Pool Standards, July 2014 (amended January 2018), which states: "If upon visual inspection the cover of a submerged suction outlet is cracked, broken, improperly secured or missing, the pump shall be immediately shut down and the public swimming pool closed, and only reopened when the cover is repaired or replaced."

AND WHEREAS, by virtue of the foregoing, the above noted premises are hereby declared to be **Closed**.

NOW THEREFORE, I hereby **ORDER** and **DIRECT**:

1. That the Owner immediately close the above noted premises.

- 2. That the Owner immediately undertake and diligently pursue the completion of the following work in and about the above noted premises, namely:
 - a. Ensure the east main drain suction outlet cover is replaced and compliant with all applicable legislation and standards. It must be installed as per the manufacturer's instructions.
 - b. Review the anti-entrapment plan and submit an updated anti-entrapment compliance plan to this office.
- 3. That until such time as the work referred to above is completed to the satisfaction of an Executive Officer of Alberta Health Services; the above noted premises shall remain closed.

The above conditions were noted at the time of inspection and may not necessarily reflect all deficiencies. You are advised that further work may be required to ensure full compliance with the Public Health Act and regulations, or to prevent a public health nuisance.
