

ORDER OF AN EXECUTIVE OFFICER

To: Theresa Jamieson

"the Owner"

RE: The food establishment located in Leslieville, Alberta and municipally described as:

Hooterville Hilton Café, 141 1 Avenue

WHEREAS I, an Executive Officer of Alberta Health Services, have inspected the above noted premises pursuant to the provisions of the Public Health Act, RSA 2000, c. P-37, as amended;

AND WHEREAS such inspection disclosed that the following conditions exist in and about the above noted premises which are or may become injurious or dangerous to the public health or which might hinder in any manner the prevention or suppression of disease, namely:

- a. The hand sink was not provided with running water.
- b. The commercial dish sanitizer was not operating.
- c. There was evidence of water infiltration at the front window.

AND WHEREAS such inspection disclosed that the following breaches of the Public Health Act and the Food Regulation, Alberta Regulation 31/2006 and the Food Retail and Foodservices Code exist in and about the above noted premises, namely:

- a. The hand sink was not provided with running water. This is in violation of the *Food Regulation* (AR 31/2006) section 17(1)(a), (e) and (f)(i) that states: "An operator must ensure that, before operation of the commercial food establishment commences, the commercial food establishment (a) is of sound construction and in a good state of repair, (e) has handwashing stations that are adequate in number and situated so as to ensure convenient access by all food handlers and (f)(i) is supplied with hot and cold running water that is safe for human consumption and available in quantities sufficient to meet the needs of the commercial food establishment."
- b. The commercial dish sanitizer was not operating. This is in violation of the *Food Regulation* (AR 31/2006) section 17(1)(a-b) that states: "An operator must ensure that, before operation of the commercial food establishment commences, the commercial food establishment (a) is of sound construction and in a good state of repair, (b) is designed so as to facilitate the effective cleaning and sanitizing of it and of all equipment, utensils and surfaces with which food comes into contact in it."
- c. There was evidence of water infiltration at the front window. This is in violation of the *Food Regulation* (AR 31/2006) section 17(1)(a) that states: "An operator must ensure that, before operation of the commercial food establishment commences, the commercial food establishment is of sound construction and in a good state of repair."

NOW THEREFORE, I hereby **ORDER** and **DIRECT**:

1. That the Owner immediately undertake and diligently pursue the completion of the following work in and about the above noted premises, namely:

- a. Repair the plumbing to the hand sink to ensure a continuous supply of hot and cold running water.
- b. Repair the existing commercial dish sanitizer or replace with a properly functioning commercial dishwasher.
- c. Repair the building envelope at the front of the café window to ensure no further water infiltration and repair or replace all water damaged materials. If mould is encountered, mould remediation must be completed.
- d. Utilize only single use dishes and cutlery until such time as the commercial dishwasher is repaired or replaced.
- e. Maintain a sink accessible and free of items at all times for the purposes of washing hands.
- 2. The work referred to in paragraph 1 a-c shall be completed by October 15, 2025.
- 3. The work referred to in paragraph 1 d-e shall be implemented immediately.

The above conditions were noted at the time of inspection and may not necessarily reflect all deficiencies. You are advised that further work may be required to ensure full compliance with the Public Health Act and regulations, or to prevent a public health nuisance.
