

ORDER OF AN EXECUTIVE OFFICER Boil Water Order

To: 655681 Alberta Ltd.

Neal Jorgenson "the Owners"

RE: The Drinking Water Supply located in Parkland Beach, Alberta and municipally described

as: Jorgy's Hot Spot, 11 Parkland Road.

WHEREAS I, an Executive Officer of Alberta Health Services, have received reports about the above noted drinking water supply pursuant to the provisions of the Public Health Act, RSA 2000, c. P-37, as amended:

AND WHEREAS such reports disclosed that the following conditions exist in and about the above noted drinking water supply which are or may become injurious or dangerous to the public health or which might hinder in any manner the prevention or suppression of disease, namely:

a. The drinking water supply may be unsafe for human consumption as evidenced by the detection of total coliforms in two consecutive bacteriological samples collected on October 14, 2025 – (Total Coliforms – Present) and October 21, 2025 – (Total Coliforms – 3 CFU/100mL), for the drinking water supply system.

AND WHEREAS such reports disclosed that the following breaches of the Public Health Act Nuisance and General Sanitation Regulation, Alberta Regulation 243/2003 exist in and about the above noted Drinking Water Supply, namely:

a. The drinking water supply may be unsafe for human consumption as evidenced by the detection of total coliforms in two consecutive bacteriological samples collected on October 14, 2025 – (Total Coliforms – Present) and October 21, 2025 – (Total Coliforms – 3 CFU/100mL), for the drinking water supply system, which is in contravention of the Nuisance and General Sanitation Regulation Section 11, which states "Where a person provided a source of water that the person intends to be used or realizes or ought to realize will be used by the public for human consumption, the person shall ensure that the water is potable".

AND WHEREAS by virtue of the foregoing, the above noted Drinking Water Supply is hereby declared **unfit for human consumption**;

NOW THEREFORE, I hereby **ORDER** and **DIRECT**:

- 1. That the Owner immediately issues a Boil Water Advisory to all users of the above noted Drinking Water Supply.
- 2. That the Owner immediately undertake and diligently pursue the completion of the following work in and about the above noted drinking water supply, namely:
 - a. Use boiled water, bottled water, or water from another safe public water source for any drinking and food preparation.

- b. Shock chlorinate the water well system and flush the lines.
- c. Provide two satisfactory bacteriological water samples that are at least 24 hours apart, to ensure that the water quality is satisfactory.
- 3. The work referred to in paragraph 2 shall be completed as soon as possible.
- 4. That, until such time as the work referred to in paragraph 2 is completed to the satisfaction of the undersigned, or an executive officer of Alberta Health Services, that this order shall remain in effect.

The above conditions were noted at the time of receipt of the reports and may not necessarily reflect all deficiencies. You are advised that further work may be required to ensure full compliance with the Public Health Act and regulations, or to prevent a public health nuisance.
