

ORDER OF AN EXECUTIVE OFFICER

To: Ahmed Kiared Professional Medical Corporation.

"the Owner"

RE: Those housing premises located in Edmonton, Alberta and municipally described as:

Unit 2 10322 95 Street NW T5H 2B5

WHEREAS I, an Executive Officer of Alberta Health Services, have inspected the above noted premises pursuant to the provisions of the Public Health Act, RSA 2000, c. P-37, as amended;

AND WHEREAS such inspection disclosed that the following conditions exist in and about the above noted premises which are or may become injurious or dangerous to the public health or which might hinder in any manner the prevention or suppression of disease, namely:

- a. No hot water services onsite.
- b. Active sewage back up noted coming from kitchen sink.
- c. No operational smoke alarm installed adjacent to sleeping areas.
- d. Both live and dead cockroach-like insects noted throughout the premises.
- e. Multiple holes in walls.

AND WHEREAS such inspection disclosed that the following breaches of the Public Health Act and the Housing Regulation, Alberta Regulation 173/99, and the Minimum Housing and Health Standards exist in and about the above noted premises, namely:

- a. No hot water services onsite. This is in contravention of section 9(a) of the Minimum Housing and Health Standards, which states that "All hot running water shall be maintained at a temperature of not less than 46 degrees C (1140F), and not more than 60 degrees C (1400F) measured at the plumbing fixture."
- b. Active sewage back up noted coming from kitchen sink. This is in contravention of section 6(a) of the Minimum Housing and Health Standards, which states that "The plumbing system and the sanitary drainage system or private sewage disposal system, as the case may be, including drains, fixtures, traps, vents, stacks, waste disposal facilities, pumpout sewage holding tanks, septic tanks and the disposal system shall be maintained in a proper operating condition."
- c. No operational smoke alarm installed adjacent to sleeping area. This is in contravention of section 12 of the Minimum Housing and Health Standards, which states that "Smoke alarms within dwellings shall be installed between each sleeping area and the remainder of the suite and, where hallways serve the sleeping areas; the smoke alarms shall be installed within the hallway. (a) Smoke alarms shall be operational and in good repair at all times."
- d. Both live and dead cockroach-like insects noted throughout the home. This is in contravention of Section 16(a) of the Minimum Housing and Health Standards, which states that "The owner shall ensure that the housing premises are free of insect [and] rodent infestations."
- e. Multiple holes in walls. This is in contravention of Section 5 of the Minimum Housing and Health Standards, which states that "All walls, windows, ceilings, floors, and floor coverings

shall be maintained in good repair, free of cracks, holes, loose or lifting coverings and in a condition that renders it easy to clean."

NOW THEREFORE, I hereby **ORDER** and **DIRECT**:

- 1. That the Owner immediately undertake and diligently pursue the completion of the following work in and about the above noted premises, namely:
 - a. Supply the premises with hot water services and provide report of repair.
 - b. Repair the drainage system, so that the kitchen sink is draining and proper working condition.
 - c. Install an operational smoke alarm and maintain it in a good condition.
 - d. Conduct the work needed to ensure all walls, ceilings, flooring, and floor coverings are in good repair, free of cracks, holes, loose or lifting coverings and in a condition that renders it easy to clean.
 - e. Hire the services of a pest control professional to treat the cockroach infestation. Provide any reports provided by the pest control professional to this office (i.e. Alberta Health Services Environmental Public Health).
- 2. The work referred to in paragraph 1 shall be completed by October 31, 2025

The above conditions were noted at the time of inspection and may not necessarily reflect all deficiencies. You are advised that further work may be required to ensure full compliance with the Public Health Act and regulations, or to prevent a public health nuisance.
