

ORDER OF AN EXECUTIVE OFFICER

RE: Those housing premises located in Edmonton, Alberta and municipally described as:

106 - 10729 108 Street NW Edmonton, AB T5H 3A4

WHEREAS I, an Executive Officer of Alberta Health Services, have inspected the above noted premises pursuant to the provisions of the Public Health Act, RSA 2000, c. P-37, as amended;

AND WHEREAS such inspection disclosed that the following conditions exist in and about the above noted premises which are or may become injurious or dangerous to the public health or which might hinder in any manner the prevention or suppression of disease, namely:

- a. The deadbolt for the front door of the unit would not engage with the door frame. As a result, the unit could not be properly secured.
- b. The egress window within the unit had been broken and covered by wooden boards. The boards did not form a tight seal and were not weatherproof.
- c. The smoke alarm within the unit was not working.
- d. The kitchen window was cracked and broken.

AND WHEREAS such inspection disclosed that the following breaches of the Public Health Act and the Housing Regulation, Alberta Regulation 173/99, and the Minimum Housing and Health Standards exist in and about the above noted premises, namely:

- a. The deadbolt for the front door of the unit would not engage with the door frame. As a result, the unit could not be properly secured. This is in contravention of Section 3(a) of the Minimum Housing and Health Standards, which states that "Exterior windows and doors shall be capable of being secured."
- b. The egress window within the unit had been broken and covered by wooden boards. The boards did not form a tight seal and were not weatherproof. This is in contravention of Section 3(b)(i) and 3(b)(ii) of the Minimum Housing and Health Standards, which states that "(i) For buildings of 3 storeys or less and except where a bedroom door provides access directly to the exterior or the suite is sprinklered, each bedroom shall have at least one outside window which may be opened from the inside without the use of tools or special knowledge. (ii) Windows referred to in section 3(b)(i) shall provide unobstructed openings with areas not less than 0.35 m² (3.8ft²), with no dimension less than 380 mm (15")." This is also in contravention of Section 2(b)(i) of the Minimum Housing and Health Standards, which states that "All windows and exterior doors shall be; maintained in good repair, free of cracks and weatherproof."
- c. The smoke alarm within the unit was not working. This is in contravention of Section 12 of the Minimum Housing and Health Standards, which states that "Smoke alarms within dwellings shall be installed between each sleeping area and the remainder of the suite and, where hallways serve the sleeping areas; the smoke alarms shall be installed within the hallway. (a) Smoke alarms shall be operational and in good repair at all times."

- d. The kitchen window was cracked and broken. This is in contravention of Section 2(b)(i) of the Minimum Housing and Health Standards, which states that "All windows and exterior doors shall be; maintained in good repair, free of cracks and weatherproof."
- e. The top of the toilet tank lid was missing. This is in contravention of Section 6(a) of the Minimum Housing and Health Standards, which states that "The plumbing system and the sanitary drainage system or private sewage disposal system, as the case may be, including drains, fixtures, traps, vents, stacks, waste disposal facilities, pumpout sewage holding tanks, septic tanks and the disposal system shall be maintained in a proper operating condition."

NOW THEREFORE, I hereby **ORDER** and **DIRECT**:

- 1. That the Owner immediately undertake and diligently pursue the completion of the following work in and about the above noted premises, namely:
 - a. Repair or replace the lock for the front door of the unit. Furthermore, remove and replace any damaged parts of the door and/or doorframe to ensure the door can be properly secured.
 - b. Replace the egress window within the living room of the unit. The egress window must provide an openable area of at least 3.8 ft² (with no dimension less than 15 inches).
 - c. Repair the windows in the living room to ensure they form a weatherproof seal.
 - d. Replace the smoke alarm within the unit.
 - e. Replace the cracked window within the kitchen.
 - f. Replace the missing toilet tank lid.
- 2. The work referred to in paragraph 1(a d) shall be completed by October 13, 2025. The work referred to in paragraph 1(e f) shall be completed by October 20, 2025.

The above conditions were noted at the time of inspection and may not necessarily reflect all deficiencies. You are advised that further work may be required to ensure full compliance with the Public Health Act and regulations, or to prevent a public health nuisance.
